Overview

Capitalization relates to an organization's flexibility to cover normal operating and artistic costs while maintaining the liquidity to manage debt, and to promptly respond to unanticipated external and/or internal emergencies as well as opportunities to invest in innovative initiatives without experiencing a negative impact on financial stability.

The Pennsylvania Council on the Arts' (PCA) capitalization pilot was developed as an extension of the capacity-building programming continuum, to support financially healthy organizations that have a proven artistic product and/or service and are committed and have reached a level of readiness to utilize contributed capital to scale up operations toward progressive growth.

Award

PCA anticipates approving one applicant with an award of \$50,000 with a 2:1 and 3:1 match requirement for years two (2) and three (3).

Project Length

The scope of this pilot project is three (3) years.

Eligibility

- Applicants must have successfully participated in the Strategies for Success capacitybuilding program at the Intermediate Level or Advanced Level;
- Applicants must have a history of operating surpluses;
- Evidence of growing demand for artistic product and/or service.

Letter of Interest (LOI) Requirements

Interested organizations are asked to submit a **Letter of Interest (LOI)** providing the following information:

- Organizational history;
- Description and growth trajectory of the artistic product(s) and/or service(s);
- Summary of the proposed strategy for capitalization; and
- Financial statements (balance sheet, income statement, IRS Form 990 for the past (3) three years.

- Letter of interest requirements

- Potential to become a growing community asset.

Review Process

Letters of Interest will be reviewed by a committee in accordance with the review criteria. Subsequently, site visits will be scheduled for those submissions that are assessed to have the best potential based on the review criteria assessment.
