In 1994, the citizens of the Commonwealth of Pennsylvania issued a clarion call for a concerted effort to respond to the crime problem in our communities.

In response, and consistent with his campaign promises, Governor Tom Ridge answered this call by convening a special session of the Pennsylvania Legislature specifically charged with enacting legislation that will address crime. Already, the legislature has enacted into law sixteen bills which seek to strengthen the criminal justice system's response to violent juvenile offenders, victims of crime, and to reform the Commonwealth's pardon's and parole systems to deal specifically with this issue. Other legislative proposals remain under consideration and are expected to be considered for enactment in the next several months.

The public's outcry for harsher sanctions for repeat, violent offenders has resulted in unprecedented state prison population growth since 1980. As a result of this growth, the Department of Corrections is currently operating many prisons in ways that they were not intended. In order to accommodate the growing inmate population we have been forced to double-cell inmates in cells designed for single housing. As of December 31, 1994, we are operating our prisons at 124 percent of capacity of 23,000. This level of crowding persists despite the Commonwealth's recent construction of five new correctional facilities and facility renovation, which resulted in a capacity increase of 10,000. Perhaps the best benchmark for system crowding is evidenced at the State Correctional Institution at Camp Hill, which currently houses more inmates than were housed there during the 1989 prison disturbances. Unfortunately, the time we spend dealing with the challenges of overcrowding competes with time available to create and maintain drug-free prisons, to create work opportunities, in short, to do a better job of managing our prisons.

To fully understand the challenges faced by the Department, a knowledge base of the offender population is required. To assist with this effort, this report presents statistical profiles on the 1994 state offender population including specific details on offender receptions and releases. The report also offers a limited historical perspective on offender profile changes from 1984 to 1994.

I trust this annual statistical report will increase your understanding of the state correctional system, its changing inmate population, and the significant challenges the Department and the Commonwealth are currently addressing.



SECTION 1: RECEPTIONS



Court commitments accounted for 62.7% of the receptions to the Department of Corrections in 1994, while parole violators represented 37.3% of the total receptions.



The Department experienced changes in the type of commitments received during the 1993 to 1994 period:

- *Receptions increased by 13.7%;*
- *Parole violators returned to the Department increased by 13.6%;*
- *Philadelphia County's court commitments increased by 13.3%;*
- *Female court commitments increased by 8.8%, while male court commitments increased by 14.3%;*



The characteristics of lifers who were received into the Department changed between 1993 to 1994:

- *Lifers received into the Department increased by 35%;*
- *Lifers received under the age of 20 increased by 175%;*



The type of offenses for which offenders were committed to the Department have also changed during the 1993 to 1994 period:


- *Court commitments for Part One offenses increased by 14.2%, while Part Two offenses also increased by 14%;*
- *Second degree murder commitments increased by 137.5% from 24 to 57;*
- *Narcotic drug commitments increased by 21.1% from 1,835 to 2,222;*







MINIMUM SENTENCE







SECTION 2: **POPULATION**



The incarceration rate in Pennsylvania increased by 8.6% from 1993 to 1994.



The incarceration rate for selected counties in the Commonwealth of Pennsylvania was characterized by varied movement from 1993 to 1994.

- *Dauphin County's incarceration rate increased from 316.5 to 382.4.*
- *Philadelphia County's increased from 712.6 to 762.8.*



The Department's offender population increased by 8.6% from 26,060 on 12/31/93 to 28,302 on 12/31/94.



Parole violators, as a percent of the total offender population, increased by 17.2% from 3,833 in 1993 to 4,493 in 1994.



The Department's capacity increased by 18.2% from 18,844 in 1993 to 22,312 in 1994.



The characteristics of offenders who were serving a life sentence in the Department has changed during the 1993 to 1994 period:

- *The number of offenders serving a life sentence increased by 7.2% to 2,806 on 12/31/94.*
- *The average age for lifers in 1994 was 38.2 years, while the average age for all offenders was 34.1 years.*
- *Lifers who have served less than 15 years in the Department accounted for 71.7% of the total lifer population.*



The number of offenders serving a minimum sentence of 20 or more years increased by 12.4% from 459 in 1993 to 516 in 1994.



GRAPH 6: COMPARISON OF CIVILIAN POPULATION AND INCARCERATION RATE FROM 1984 TO 1994







GRAPH 8: OFFENDER POPULATION VERSUS STATE PRISON CAPACITY, DECEMBER 31, 1984 to 1994







SECTION 3: RELEASES



The total number of releases increased by .6% from 1993 to 1994 from 8,426 to 8,481.



The average time served for offenders convicted of Part One offenses was 53.3 months, while Part Two offenders served 35.2 months.



The average time served for narcotic drug offenders released during 1994 was 33.9 months.



The average time served for all sentences nearly doubled from 1984 to 1994 from 25.7 months to 49.2 months.



For 1992, the latest year available for comparison, the average time served for violent offenders released in Pennsylvania was 50 months, while the national average was only 38 months.



The rate of paroles granted by the Pennsylvania Board of Probation and Parole decreased 6.5% from 73.0% in 1993 to 66.5% in 1994.



The type of releases from the Department was characterized by varied movement for the period 1993 to 1994:

- *The number of conditional releases increased by 1.4%.*
- *The number of unconditional releases decreased by 3.8%.*



GRAPH 11: DISTRIBUTION OF 1994 RELEASES BY TYPE



DEPARTMENT INMATES, 1984 to 1994







THE DEPARTMENT, 1984-1994







GLOSSARY

GLOSSARY

CAPACITY: The maximum number of beds a facility was originally designed for, plus beds added or eliminated due to conversions or additions.

COMMUTATIONS: A change of a legal penalty or punishment to a lesser one. A commutation for a lifer is the establishment of a parole date.

CONDITIONAL RELEASE: The release of an inmate from the Department of Corrections to another supervising authority. This method of release includes the following types:

State Parole: When an inmate is released to the community and is supervised by the Pennsylvania Board of Probation and Parole.

County Parole: When an inmates is released to the community and is supervised by a county parole board.

Reparoled (State): When an inmate is released to the community and is supervised by the Pennsylvania Board of Probation and Parole, after the inmate had been previously paroled and violated the conditions of the parole.

COUNTY TRANSFERS: When an inmate who is serving a county sentence is transferred to the Department of Corrections. The reason for the transfer could be for security or medical reasons.

COURT COMMITMENTS: A commitment imposed on individuals by a court to a state correctional institution.

DETENTIONERS: An inmate who is being housed in a state correctional institution at the request of another governmental jurisdiction.

ESCAPE: The intentional act of an inmate to leave the custody of the Department of Corrections. The act of escape includes the following types

Breach: When an inmate in the process of intentionally leaving the custody of the Department of Corrections compromises the security perimeter of the institution.

Others: Includes walkaways that occur outside the wall/fence while on work detail, work and/or educational release and furlough.

INCARCERATION RATE: The number of inmates incarcerated per 100,000 Pennsylvania civilian population.

LIFER: An individual who is convicted of criminal homicide and sentenced to remain in prison for their natural life without possibility of parole.

GLOSSARY

MINIMUM SENTENCE: The minimum amount of time imposed by the court that an inmate must serve before being eligible for release from prison.

MAXIMUM SENTENCE: The maximum amount of time imposed by the court that an inmate must serve before being released from prison.

PAROLE VIOLATORS: Persons who have been paroled from prison and have violated the terms and/or conditions of their parole. Parole violators are generally classified as technical or convicted violators. Technical violators are recommitted for failure to adhere to the requirements of their parole plan (ie.. non-reporting to agent or program, drug violations, etc.), while criminal violators are found guilty of new criminal offenses.

PART I OFFENSES: Offenses identified by the Uniform Crime Report which are of a serious nature and are usually reported to law enforcement agencies. Crimes identified as Part I offenses include: criminal homicide, forcible rape, robbery, assault, burglary, larceny-theft, motor vehicle theft and arson.

PART II OFFENSES: Offenses not classified as a Part I Offense as defined above.

SENTENCED: Inmates who are serving time on court imposed sentences, as compared to an inmate who serving time because of parole violations.

UCR REPORTED CRIME RATE: The number of UCR Total Index Crimes per 100,000 Pennsylvania residents.

UCR TOTAL INDEX CRIMES: Offenses which are most serious and most likely to be reported to police. These index crimes are used as a standard for comparison. Index crimes include: murder and non-negligent murder, forcible rape, robbery, aggravated assault, burglary, larceny-theft, motor vehicle theft and arson. Manslaughter by negligence is not included as an index crime.

UNCONDITIONAL RELEASE: The means of release for inmates who have either served their maximum sentence or have had their sentences reduced or vacated by the court.
