So long as Tenant does not wrongfully withhold the payment of rent or fail in the performance of any of the terms, covenants or conditions of the Lease requiring performance on the part of Tenant, (a) the Mortgagee will not join Tenant as a party defendant in any action or proceeding for the purpose of terminating any ownership, possession, interest of estate of Lessor because of any default under the Mortgage, and (b) the Lease and the rights of Tenant thereunder shall not be divested by a sale on the Mortgage or on the obligation secured by the Mortgage or the exercise of any other right or remedy available to the Mortgagee against the Lessor.
- 2. If the Leased Premises or any portion thereof affecting the Tenant shall be transferred to and owned by Mortgagee, or any assignee or purchaser at judicial sale or any transferee under an action in lieu thereof, by reason of foreclosure or other remedial proceedings brought by Mortgagee or any assignee or Mortgagee or transferee or purchaser or by any other similar manner or if the interest of Lessor is terminated or assigned by any action of the Mortgagee, Tenant's rights shall not be terminated thereby, rather Tenant shall be bound to Mortgagee or any such assignee, purchaser or transferee under all of the terms, covenants and conditions of the Lease for the balance of the term thereof remaining, with the same force and effect as if Mortgagee or any such assignee or purchaser or transferee were the lessor under the Lease with the Lease remaining in full force and effect.
