Typewritten is preferred. If handwritten, the form must be legible and completed in black or blue ink in order to permit reproduction.

The nonrefundable filing fee for this form is \$70. Checks should be made payable to the PA Department of State. Checks must contain a commercially pre-printed name and address.

This form and payment should be mailed to the address stated above.

Who should file this form?

All registrants of insignias or marks used with articles and supplies that have not made a new or amended filing with the Bureau of Corporations and Charitable Organizations (Bureau) from January 1, 2012, through December 31, 2021, must file a report that the insignia or mark continues to be used. This report must be filed with the Bureau during the calendar year 2021. Trademarks and service marks are not required to make decennial filings, but are required to renew every five years.

No decennial filing is required if the registrant has made any filing (such as amendment to the registration) in the Department from January 1, 2012, through December 31, 2021, *other than* a decennial report.

What happens if a decennial report is not filed?

If a required decennial report is not filed for an insignia or mark during the calendar year 2021, the insignia or mark ceases to be registered beginning January 1, 2022. The registration may be restored only by the filing of a new registration and the appropriate fee.

Form Instructions

Enter the name and mailing address to which any correspondence regarding this filing should be sent. This

field must be completed for the Bureau to return the filing. If the filing is to be returned by email, an email address must be provided. An email will be sent to the address provided, containing a link and instructions on how a copy of the filed document or correspondence may be downloaded. Any email or mailing address provided on this form will become part of the filed document and therefore public record.

1. Give the exact name of the insignia or mark as registered with the Department of State. This field is required.

2. Give the exact name of the registrant as identified in the records of the Department of State. This field is required.

3. Address. Enter the address where the mark or insignia is registered as presently identified in the records of the Department of State. If the registrant's address has changed and differs from what is presently on the Department's records, the registrant's new address should be identified in Field 3. This field is required.

4. Change of Address. If the address in Field 2 has been changed and the registrant's address differs from what is presently on the Department's records, the registrant's new address should be identified. Under 15 Pa.C.S. § 135(c) (relating to addresses), an actual street or rural route box number must be used as an address, and the Department of State is required to refuse to receive or file any document that sets forth only a post office box address.

5. Mandatory statement. This field is required.

6. Mandatory statement. This field is required.

Signature and Verification

The Decennial Report must be signed by the registrant of the mark or insignia. Signing a document delivered to the Department for filing is an affirmation under the penalties provided in 18 Pa.C.S. § 4904 (relating to unsworn falsification to authorities) that the facts stated in the document are true in all material respects. **This field is required.**
