Subj: Two-Percent Election Audit

On Friday, November 8, 2024, the two (2) percent audit of ballots cast in the 2024 General Election was conducted in Bedford County.

Precinct Selection

Election Day ballots from Juniata Township were selected as our 2% number of 483 fell within the Township's total of 502. All 502 Election Day ballots were counted in the audit.

- Representative in Congress 13th District
- Representative in the General Assembly 78th District

Audit Method

The audit was a cumulative hand count of the precinct's ballots with Deb Brown reading the ballot info and five members tallying the results.

Hand count totals were checked against the unofficial election results for the precinct. No discrepancies were identified.

Results

The audit involved the hand counting of a total of 502 ballots (2.2% of ballots cast.) The hand count results matched the results of ballots scanned at the precinct on Election Day. The tally results for the precinct are attached.
