Dear Members of the General Assembly:

As Secretary of the Commonwealth, I am pleased to report to you on the administration of voter registration in Pennsylvania for calendar year 2008. I trust you will find the content of this report useful.

In 2008, the Department of State's ongoing partnership with the Commonwealth's 67 county election boards, voter registration commissions, agency-based voter registration programs and other groups resulted in the addition of 493,606 voters to the voter registration rolls.

The Department continued its collaboration with Commonwealth agencies designated with responsibilities under the National Voter Registration Act of 1993 to administer voter registration programs. This included the provision of training and supplies in support of the agencies' efforts.

In accordance with Act 3 of 2002, the Department implemented improvements to the Statewide Uniform Registry of Electors (SURE) system and related county and public portals. Enhancements to the system have benefited the public as well as county and state election officials. SURE is and will continue to be integral to the success of Pennsylvania's electoral process well into the 21st Century.

The Department remains committed to fulfilling its responsibilities under the Help America Vote Act of 2002. Staff will maintain efforts to promote voter registration, awareness and outreach activities across the Commonwealth.

The Administration of Voter Registration in Pennsylvania
2008 Report to the General Assembly

In 2008, the Department of State (Department) worked closely with the 67 county voter registration offices, Commonwealth agencies designated with voter registration responsibilities, the public, voter registration advocacy groups and the affected state and local agencies to administer voter registration in Pennsylvania. This report represents a summary of initiatives and statistics that support voter registration administration in Pennsylvania.

Department of Transportation

Since 1995, the Pennsylvania Department of Transportation (PennDOT) has played an integral role in the voter registration process. PennDOT provides Commonwealth citizens with an opportunity to apply to register to vote while receiving or renewing their driver's license at a PennDOT photo license center. In 2008, more than 289,000 individuals applied to register to vote using this resource.

Application Process to Register to Vote at a Photo License Center

- PennDOT customers visit a photo license center with a driver's license application card, provided by PennDOT, which contains a printed two-dimensional bar code. The bar code is scanned, and the computer system determines the customer's age. It then determines which customers will be at least eighteen years old by the date of the next election and asks if the customer wishes to apply to register to vote.
- The program is designed to ask customers if they are already registered to vote. If not, they are provided the opportunity to apply to register.
- Customers can view the qualifications a Pennsylvania citizen must meet to continue with the application.
- Customers who choose to apply for voter registration are asked to confirm their county of residence, indicate a party preference and type their telephone number and race, which are both optional.
- Customers are advised of the penalty for furnishing false information and are asked to sign a declaration that the information they have provided is true and correct to the best of their knowledge.
- Customers are provided a receipt indicating pertinent information about their voter registration application, including the date on which they applied at the photo license center. The receipt instructs customers to contact their county voter registration office if they do not receive a voter identification card within two weeks.

The PennDOT computer system stores the completed voter registration applications and transmits the data to VIISAGE, the contracted vendor. The vendor electronically sorts

the applications by county and transmits them electronically to each county voter registration office. In 2008, the vendor forwarded 289,195 "motor voter" applications to county voter registration officials.

PennDOT provides address change information to the Department. The Department forwards the information to the appropriate county voter registration office. In 2008, the Department forwarded 792,288 changes of address from PennDOT to county officials.

Agency Registration

In 2008, the Department continued to work with state-operated public assistance agencies and agencies that serve people with disabilities to provide registration opportunities to clients. The following agencies participated:

County Assistance Offices; Clerk of Orphans' Court and Marriage License Bureaus; Armed Forces Recruitment Centers; Women, Infants, and Children Nutrition Clinics; District Offices of the Office of Vocational Rehabilitation; District Offices of the Bureau of Blindness and Visual Services; State Mental Health Hospitals and State Mental Retardation Centers; the Area Agencies on Aging; Contractors for the Bureau of Blindness and Visual Services; Centers for Independent Living; County Mental Health and Mental Retardation Offices; Student Disability Services Offices of the State System of Higher Education; the Offices of Special Education; and the American with Disabilities Act Complementary Para-transit Offices.

To assist these agencies, the Department continues to provide the *Pennsylvania Guide to Agency-Based Voter Registration*. This publication details the responsibilities of a mandated voter registration agency. In addition to this guide, the Department provides each agency with Voter Registration Mail Applications, posters encouraging voter registration and brochures, including the *Pennsylvania Voting Guide*, which describes the voter registration process.

The Department also conducts training sessions and provides technical assistance to agencies when needed. These agencies provide approximately 1,500 additional sites where individuals are offered the opportunity to apply to register to vote.

The Help America Vote Act (HAVA): Act 150 of 2002 and Act 97 of 2004

President George W. Bush signed the Help America Vote Act (HAVA) of 2002 into law on October 29, 2002. HAVA's main objective is uniform and non-discriminatory election administration. The Act contains several provisions related to voter registration, poll worker training and accessibility requirements. Such requirements extend to language and physical accessibility.

Pennsylvania enacted Act 150 of 2002 to incorporate many HAVA requirements into the Pennsylvania Election Code. Act 97 of 2004 made additional amendments to procedures applicable to provisional ballots, as noted below.

Poll Worker/Election Official Training

The Department developed a second Election Officials Training Program DVD, which was distributed to all counties to ensure a uniform training program in the Commonwealth of Pennsylvania. This training DVD was designed to assist voters with different types of disabilities on Election Day. The video was developed in conjunction with the Governor's Cabinet and Advisory Committee for People with Disabilities and other key personnel that provided feedback in the development and filming of the video.

Polling Place Accessibility

After receiving completed surveys from the counties, the Department created and maintained a survey results database to allocate and distribute all Title II, Section 261 funds. The Division of HAVA has started working with the Division of The Statewide Uniform Registry of Electors (SURE) to utilize the information that the counties enter into the SURE Portal. By working with SURE, HAVA will be able to obtain up-to-date information on the accessibility status of each county and subsequently reduce the workload of the counties. It is our hope that this combined effort will yield more accurate information.

The Department applied for federal assistance (SF-424) and received \$458,011.00 for fiscal year 2008. The funds were disbursed in the following percentage (10% for polling place accessibility, 80% for compliant voting systems, 5% for training election staff and 5% for voter information programs).

For fiscal years 2003 through 2008 the Commonwealth allocated a total of \$2,508,545.00, in Title II, Section 261 grants as follows:

- \$1,230,320.40 for making polling places accessible to individuals covering a full range of disabilities. This includes the path of travel, entrances, exits and voting areas of each polling facility.
- \$449,956.50 for providing equal opportunity for access and participation (including privacy and independence) to individuals covering a full range of disabilities as for other voters.
- \$185,138.55 for training election officials, poll workers and election volunteers on how best to promote access for individuals covering a full range of disabilities in elections for federal offices.
- \$185,128.55 for providing individuals covering a full range of disabilities with information about polling place accessibility.

Alternative Language Assistance

Pursuant to Section 301 of HAVA, since 2005, the Department continues to translate all relevant voter materials into Spanish and other languages. The Department maintains its VotesPA.com website. This site is completely translated into Spanish, but also has key documents translated into Chinese, French, Korean, Khmer, Russian and Vietnamese.

The Statewide Uniform Registry of Electors (SURE); Act 3 of 2002

SURE is the centralized voter registration and election management system designed to assure the accuracy and integrity of the Commonwealth's voter registration records maintained by the election authorities of Pennsylvania's 67 counties. The SURE system is a platform that supports the critical functions of the Commonwealth's elections—from determining voter eligibility to assigning precincts to producing poll books. A centralized, uniform registry that is accessible to all county offices greatly enhances the overall accuracy and integrity of the voter registration rolls and the resulting quality of voter services.

Pennsylvania began development of its centralized voter registration system with the enactment of Act 2002-3 (Act 3). Act 3 set forth the requirements for the system, specifying that SURE must be a “single, uniform integrated computer system. All [voter registration] commissions shall be connected electronically to the SURE system and shall maintain their registration records in the system.” Act 3 also made a number of amendments to the voter registration act that make voter registration processes more amenable to electronic processing.

HAVA contains numerous requirements for improving the conduct of elections across the United States. One of these requirements is the establishment of a statewide voter registration system in each state, which must be a “single, uniform, official, centralized, interactive computerized statewide voter registration list defined, maintained, and administered at the State level that contains the name and registration information of every legally registered voter in the State and assigns a unique identifier to each legally registered voter in the State...” (See § 303(a)(1)(A), 42 U.S.C. § 15483(a)(1)(A)). The SURE system went “live” in all Pennsylvania counties prior to the January 1, 2006, HAVA deadline.

Following the completion of a Gap Analysis on the project in January 2007 to assess future needs, the Department, in consultation with the Governor's Office of Administration, pursued a contract with a vendor to re-host the SURE system program. The intent was to improve and tailor the system for the future needs of the Commonwealth. A contract was signed with Diverse Technologies Corporation in June 2007 to complete the SURE Rehosting Project.

The primary objective of the Rehosting Project is to migrate the SURE system application from its outdated Microsoft Access platform to a more state-of-the-art

technology based on the Microsoft .NET platform. The Rehosted SURE system was deployed to production in December 2008, and improvements continue to be made to the system to enhance functionality and performance. Because the Commonwealth now owns and maintains the SURE system programming code, the Department will be able to make enhancements to the system in the years ahead based on the needs of users and of the Commonwealth.

SURE Portal

As the SURE project developed and expanded over the past several years, it became apparent that there were many areas of voter registration and election management that could be addressed and improved outside of the SURE system. The Department embarked on the SURE Portal project in 2005 in order to address some of these issues, while taking advantage of the progress that has been made in the Commonwealth with the SURE system.

The overall goals of the SURE Portal are:

- To make use of SURE information to support an expanded array of services and functionality for county, agency, and public users.
- To move some critical county processes outside of the SURE environment, optimizing performance for the official registration system.
- To make SURE information more readily available for county, agency and public use and reference.
- To provide streamlined, electronic processes to county offices to support voter registration and elections.
- To make voter registration and election information available to the public via the Internet.

Three separate functional areas make up the SURE Portal: the Public Portal, the County Portal and the Agency Portal.

The SURE Public Portal provides access to many aspects of the voter registration and elections processes directly to the public via the Internet at www.pavoterservices.state.pa.us.

On the SURE Public Portal, voters may:

- Search for and view their own registration and polling place information, including directions to their polling place.
- Print a voter registration application and absentee ballot request form.
- Access valuable information regarding the elections process in their own counties, including information on voting systems and county-specific office information, polling place information, news, FAQs, events and links.
- Search for the status of their provisional ballots.

- Participate in a threaded online discussion.
- Search for a *Voter Hall of Fame* inductee.

The SURE County Portal was developed with the intent of expanding the range of voter registration and election management functions that can be performed by county users outside of the SURE system proper. Users of the County Portal do not necessarily have to be users of the SURE system. This makes it possible to allow temporary workers, for example, to perform many election-related duties without accessing the SURE system. This ability allowed several counties to expand their data entry capacities to successfully handle the large number of voter registration applications received prior to the Primary and General Elections last year. The County Portal provides the following functions to county users:

- Voter search capability.
- Scanning and data entry of voter registration applications (entered into the Portal and imported into SURE via the Dynamic Import Process).
- Posting of county-specific office information, polling place information, news, FAQs, events and links to the SURE Public Portal.
- Entry, processing, and certification of provisional ballots.
- Voter registration statistics certification.
- Report generation and printing.
- Verification of voting system software.
- Upload of election returns to the Department.

In addition, Public Kiosk accounts have been requested in 19 counties as a part of the County Portal. This feature was developed so that county election offices may, if they choose, provide a public computer terminal to customers so that they can access many features of the SURE Portal in the county office. Public users of the Kiosk have the ability to perform the following functions:

- Search for and view voter registration information for any voter in the county (after completing an affirmation and showing identification to an election official).
- Change their voter registration information or complete a new application electronically (application is submitted directly to SURE for processing by the county).
- Access valuable information regarding the elections process in their own counties, including information on voting systems and county-specific news, FAQs and links.
- Search for the status of their provisional ballots.

The SURE Agency Portal provides useful elections functionality to the Department. During the busy period prior to the 2008 General Election, the SURE Portal allowed Bureau of Commissions, Elections and Legislation (BCEL) employees to assist county election officials by data entering voter registration applications for subsequent

verification and approval in the counties. The functionality provided to Department users by the SURE Agency Portal includes the ability to:

- Research registered voters through the lookup capability as requests are received.
- Accept voter registration statistics and election returns from county voter registration offices electronically via the SURE Portal.
- Post statewide news, links, FAQs and voting system information to the SURE Public Portal.
- Data enter voter registration applications for verification and approval in the voter's county of residence.

The SURE Agency Portal also provides the ability for the Department to deploy Public Kiosks for customer use.

In early 2008, the SURE Portal Team deployed versions 5.0 and 6.0 of the application, which included enhancements for the public and for county election officials. In March, version 5.0 of the SURE Public Portal was launched, which included a new pictorial menu on the public website. This user-friendly interface contains several visual links designed to assist voters with finding the most frequently needed information and resources:

- Clicking on the **Find Your Polling Place** link permits citizens to locate a polling place associated with a particular residential address by simply entering in the address. Upon searching, polling place information, including location, address, accessibility information, and options to obtain directions to the polling place, are presented.
- Selecting **Apply to Register to Vote** or **Change your Voter Registration** presents citizens with a link to a voter registration application, which can be downloaded, completed, signed and sent to the appropriate county office. A link to county contact information and information regarding the deadline to register for the upcoming primary or election is also provided.
- Clicking the **Apply for an Absentee Ballot** link provides citizens with information regarding absentee ballots. Links to the absentee ballot application are also available to download, complete, sign and send to the appropriate county office.
- The **Find Voter Registration Status** link allows registered voters to confirm their registration status and party affiliation, as well as locate their polling place by entering simple demographic data.

Version 6.0 of the SURE County Portal was launched in May of 2008. Improvements to the launch and login process were included in this release, along with implementation of Election Night Returns (ENR) functionality. ENR allows the SURE County Portal to facilitate the electronic transfer of election night returns from the county offices to the Department. During the 2008 Primary, 20 counties used the ENR functionality to transmit election returns to the Department for immediate posting and tallying on the

Department's website. In November of 2008, 54 counties utilized ENR, resulting in the most expeditious reporting of election night returns ever provided by the Department.

In addition to the online public component, the following users have been granted access and are utilizing their respective areas of the Portal:

- Agency Users: The Department's BCEL and the Pennsylvania State Police.
- County Users: Only four counties remain to be deployed to the SURE Portal (Blair, Delaware, Sullivan, and Philadelphia). Users in all other counties utilize the SURE Portal for various functions.

The Department continues to explore ways in which SURE and the SURE Portal may be improved and enhanced to allow citizens, as well as county and state officials, to participate more fully in the election process. SURE will inevitably continue to play an important role in the future of the Commonwealth's system of elections.

Election Assistance Commission (EAC) Election Data Collection Grant

In April of 2008, the Department applied for one of five \$2 million grant awards from the U.S. EAC for the purpose of reporting precinct-level voter registration and election data for the 2008 November Election, and for the purpose of developing a system to enhance the collection of such voter registration and election data into the future. On May 28, 2008, the Department was notified that it was awarded one of the five available \$2 million Election Data Collection grants.

As outlined in its grant proposal, the Department began work on the following three-phase project plan in June 2008 to meet the objectives of the grant program:

Phase 1 Enhancements:

- a) Merge precinct-level data collection into the SURE Portal for registered voters; absentee balloting; UOCAVA balloting; and provisional balloting to enable data to be collected and compiled electronically (Election Day Survey Repository).
- b) Build a "dynamic reporting environment" to more efficiently gather and report data from the various databases.

Phase 2 Enhancements:

- a) Identify and develop enhancements to SURE user interfaces (SURE and the SURE Portal) to promote more efficient tracking and reporting of election data.
- b) Further augment the reporting structure built during Phase 1 of the project to make submission of EAC data an "almost automatic" process.

Phase 3 Enhancements:

- a) Enhance the SURE Portal to include all functionality that exists in the AS400-based internal Elections Management System currently used by the Department to track primarily candidate and election return data.
- b) Successfully migrate all remaining election management processes into the SURE Portal.
- c) Eliminate the internal Elections System as the primary platform for elections processes.

At the completion of the project, the Department will have built an integrated election management system within the SURE Portal that provides all of the functionality of the Department's current internal elections system, and also provides the enhanced data collection capabilities of the Election Day Survey Repository built during the first two phases of the project.

Voter Outreach Efforts

Pennsylvania Voter Hall of Fame

The Department administers the Pennsylvania *Voter Hall of Fame* program. The program was established to generate awareness and encourage Pennsylvanians to exercise their right to vote. This program publicly honors Pennsylvanians who have voted in at least 50 consecutive November elections. *Voter Hall of Fame* inductees serve as ambassadors for voter participation, encouraging others to emulate the inductees on its website as well as a permanent display on the third floor of the North Office Building in Harrisburg.

In 2008, the Department inducted 578 citizens from 14 counties into the *Voter Hall of Fame*. The 578 new members bring total membership to 13,760. Members of the Pennsylvania *Voter Hall of Fame* represent 64 different counties across the Commonwealth.

Vote With A Vet Program

In the fall of 2008, the Department, in cooperation with the Departments of Education and Military and Veterans Affairs, conducted its *Vote With a Vet* program. This program is conducted every two years during the General Election as an attempt to reverse the trend of apathy among younger voters by impressing upon them the sacrifices Pennsylvania veterans have made to safeguard our democracy. The Department gathers

detailed biographies of Pennsylvania veterans from across the Commonwealth. These biographies are sent to Pennsylvania schools, along with Voter Registration Mail Applications. Since the program's inception, the Department has mailed more than 16,000 biographies to age-eligible students.

In October of 2008, the Department sent out Voter Registration Mail Applications and Veteran biographies to 49 High Schools across the Commonwealth. More than 1,200 students participated in the program and it concluded in a great success. Students also had the opportunity to participate in honoring a deceased veteran.

The Department encourages members of the General Assembly who are veterans to complete a "Veteran Biography Form." Anyone may complete a "Deceased/MIA Veteran Biography Form" on behalf of a veteran. Please contact the Department's BCEL to request either form.

Student Mock Election

In 2008, with the assistance of the Department of Education, the Department of State conducted the 2008 *Pennsylvania Student Mock Election Program*. This program, initiated in 1988, is held every two years during the General Election as an attempt to educate school-age youth about the voting process. Students participate in a mock election in their respective schools throughout the Commonwealth and vote for offices such as President and Vice President or Governor and Lieutenant Governor. The ballot also contains several ballot questions, including school and education-related issues, to promote and encourage participation in the program.

Over 1,500 Schools involving more than 172,000 students participated in this program. Each participating school received a Teachers' Manual to assist educators in administering the Mock Election. All schools reported their election results for President, Vice-President and statewide offices online.

Community Outreach Efforts

In 2008, the Division of Voter Registration reached out to various high schools, community groups and organizations in an effort to increase voter registration totals and voter education across the state. This included speaking at high schools, press conferences and attending local meetings to emphasize the importance of promoting voter registration.

The Department takes voter education seriously. Moreover, continuous efforts to increase voter registration awareness will be a priority for years to come.

- Appendix I shows voter registration figures by county and political party as of December 31, 2008.
- Appendix II offers a comparison of voter registration totals from 2006-2008 as of the close of registration prior to each November Election. DEM: Democratic Party; REP: Republican Party; INC: Increase in party registration; DEC: Decrease in party registration.
- Appendix III shows data for the various voter registration methods. Total registration activity processed captures new registrations, changes of address (out of county) and changes of name or party. Also provided is the number of new registration applications that were accepted by the county voter registration commissions. This appendix includes column charts. The first presents new applications as a subset of total activity. The next depicts various sources of new applications from 2006-2008.

For the agencies that are listed in Appendix III on both charts on pages 17 through 20, please note the agencies are complying with both federal and state laws to provide voter registration opportunities to their clients.

Beginning in January 2008, in an effort to increase the reporting of statewide voter registration agency totals, the Department initiated the following actions:

- Provided training for agency coordinators;
- Met with site coordinators from agencies for training;
- Supplied agencies with voter registration applications, informational pamphlets and posters;
- Contacted other agency officials to designate additional employees to monitor and coordinate the reporting of agency voter registration totals;
- Redesigned the Voter Registration Mail Application form to enhance reporting by both agency and county voter registration offices by using forms that are pre-coded for each agency;
- Redesigned and rewrote the *Pennsylvania Guide To Agency-Based Voter Registration*;
- Communicated with county voter registration officials about entering agency codes as they register new voters and voters who are updating their voting information; and
- Reached out to agency Secretaries across the Commonwealth and requested their assistance to see that every site has a coordinator and this responsibility is written into the appropriate position description. The Department did this in an effort to achieve ongoing continuity of service at all required sites.

With the ongoing efforts of the Department, other agencies and county voter registration offices, we anticipate that voter registration totals for 2009 will more accurately reflect the ongoing voter registration opportunities that are provided to Pennsylvania citizens.

- Appendix IV presents data relative to list maintenance activities in the counties for the period covered by this report. In addition to confirmation mailings and the National Change of Address Program, list maintenance activities include the number of changes of address received from PennDOT and processed, the number of address verification notices mailed in accordance with Section 1901 (d)(2) of Act 3, the number of five-year notices mailed and the number of responses to these notices, the number of registration files marked inactive at the end of 2008, and the number of active and inactive voter registrations which were cancelled. (The “motor voter” litigation settlement agreement permits the counties to send out five-year notices in accordance with Section 1901 (b)(3) of Act 3.) In some instances the five-year notices were mailed in the prior calendar year and the responses to the notice received in 2008.
- Appendix V gives data for “motor voter” applications by political party. This information is provided directly by DataCard/VIISAGE Corporation, the contracted vendor who processes the applications for the Department and PennDOT. These

statistics relate to the number of individuals who applied to register to vote at a photo license center. The total number of applications provided by VIISAGE may differ from the counties' total applications received from PennDOT for a variety of reasons, including not having been received by the counties until the next reporting period.

- Appendix VI illustrates the number of changes of address received (both in-county and out-of county) by PennDOT that were forwarded to the county voter registration commissions. These numbers differ from the numbers reported in Appendix IV because they include all changes reported to PennDOT regardless of whether or not the individual was registered.
- Appendix VII depicts a pie chart listing the distribution of the Voter Registration Mail Applications. This chart does not reflect distributions to the 67 county voter registration offices.






