➤ Why is the follow-up survey needed?

- To meet Perkins V federal accountability requirements
- To evaluate performance of registered Career and Technical Education (CTE) Adult Affidavit Programs (AAPs)
- To enhance available data needed for CTE program evaluation and improvement efforts

▶ Which adult students are included in the survey?

Perkins V accountability definitions require PDE to survey adult CTE students who completed (CTE status type code of 41) their CTE program during the 2022-23 reporting year.

Which secondary students are included in the survey?

Perkins V accountability definitions require PDE to survey CTE concentrators who exited a secondary CTE program during the 2022-23 reporting year.

The Perkins secondary follow-up indicator includes secondary CTE 12th grade students reported in PIMS as:

- (1) Perkins Concentrator; AND
- (2) CTE status type code from PIMS Manual Volume 2, Appendix P, indicating that the student either graduated or dropped out.

Students who should complete the follow-up survey

PDE provides a report to LEAs (via PIMSReportsV2 application) listing students who need to complete the survey.

For Adult Education:

CTE > Adult > Follow-Up > List of Adult CTE Students to Survey

For Secondary Education:

CTE > Secondary > Follow-Up > List of Secondary CTE Students to Survey

These reports, which can be downloaded as PDF, Excel, Excel Data, HTML or CSV, provide student demographics to assist with a mail merge. Two other important data elements are in the reports:

- Security Code – needed for a student to log into web survey
- Survey Submitted

▶ Completing the web-based survey

How can LEAs notify students to complete the web-based survey?

- Mail
- Email/Social Media
- Phone
- Any combination of above

What if students do not have direct access to the internet?

- Students may access the internet via a library or their school.
- With the student's permission (written or verbal), LEAs may enter the student's survey response data.

Timeline

- April 22 LEAs complete first wave of student communications
- June 3 LEAs complete second wave of student communications
- July 15 LEAs complete third wave of student communications
- August 31 PDE closes follow-up web survey application

Best practices

- Update student contact information upon student exiting LEA
- Maintain or update contact information through alumni group/social media
- Obtain student responses to questions, along with permission for LEA to enter into website at the same time
- Ensure the responses reflect student status six months after exiting LEA
