 - Goal high-quality programs, student success



Purpose – Required Activities

- Required Activities
 - Alignment of adult education activities with other core programs
 - Professional development to improve the quality of instruction
 - Technical assistance to adult education providers
 - Monitoring and evaluation

- Permissible Activities
 - 13 permissible activities in addition to the 4 required activities

- Professional Learning Opportunities
 - Coordinate, develop, and deliver high-quality professional learning opportunities to improve the quality of instruction
 - Maximum \$700,000
 - Appendix A of Request for Grant Application Guidelines (RGA)



Technology

- Provide instructional design and technology support to other leadership projects to create and revise high-quality online professional development opportunities
- Provide technical assistance in the use of instructional technology to other leadership projects
- Maximum \$475,000

 - Manage the dissemination of information and resources
 - Maximum \$100,000

- MIS/eData Tech Support
 - Manage the eData system
 - Provide technical assistance on its use
 - Maximum \$165,000

 - Provide technical assistance to
 - Align workforce development programming
 - Build capacity to address WIOA
 - Function effectively as a partner in Pennsylvania's workforce development system
 - Maximum \$275,000

Application Components

- Narrative (scored)
 - Each priority has a separate grant application with different questions
 - Basis for analysis of the applicant's ability to provide the required services
- Budget (not scored)
 - Demonstrates fiscally sound allocation of funds to successfully provide the services and activities described in the narrative
 - See section 600 in the Adult Education and Family Literacy Guidelines for detailed information

- Timely submission
- Complete
- Scoring
 - See application review guide in appendices
 - Teams PDE staff, other Commonwealth staff, and peer reviewers



Grant Term and Notification Process

- Term
 - One year
 - Optional renewal for three additional years
- Selection and notification
 - Awards to highest score for each priority
 - Successful applications may require revisions
