Statement of Financial Interests Electronic Filing Manual

Key Information:

- 1) Browser Requirements: **Internet Explorer 9** and above, **Google Chrome** or **Mozilla Firefox**.
- 2) All fields with an asterisk (*) are required fields and must be completed.
- 3) If amending a form which was previously filed on the Commission's website, choose that option (see Step 5 below).
- 4) After submitting the form, the filer can obtain an official copy from the State Ethics Commission's eLibrary at: www.ethics.pa.gov then clicking on the e-library icon. The filer may also supply their e-mail address when submitting the form for an official copy to be sent via e-mail.
- 5) The filer can print this form from their web browser; however, it does not constitute an official copy of their filing.

Note: Any filings made by other Public Officials/Public Employees will be considered voluntary. All filers will still need to submit a paper version and/or a copy of their electronically filed form to all required filing locations other than the State Ethics Commission.

Step 2: Click "Program and Services" then the arrow under "File a Statement of Financial Interests":

Step 4: The page below will be displayed; read the text and then check the box below:

THIS FORM MUST BE COMPLETED AND FILED BY:

A: Candidates - Persons seeking elected state, county and local public offices, including first-time candidates, incumbents seeking re-election, and write-in candidates who do not decline nomination/election within 30 days of official certification of same.

B: Nominees - Persons nominated for public office subject to confirmation.

C: Public Officials - Persons serving as current state/county/local public officials (elected or appointed). The term includes persons serving as alternates/designees. The term excludes members of purely advisory boards.

D: Public Employees - Individuals employed by the Commonwealth or a political subdivision who are responsible for taking or recommending official action of a non-ministerial nature with regard to: contracting or procurement; administering or monitoring grants or subsidies; planning or zoning; inspecting, licensing, regulating or auditing any person; or any other activity where the official action has an economic impact of greater than a de minimis nature on the interests of any person. The term does not include individuals whose activities are limited to teaching.

A former public official or former public employee must file the year after termination of service with the governmental body.

E: Solicitors - Persons elected or appointed to the office of solicitor for political subdivision(s).

Step 7: Continue to fill out all fields as required. All fields that contain an asterisk must be completed. For field 7, the year is already defaulted (see screen shot below); however, if filing for previous years and not the current year, the year should be updated accordingly.

Note: Forms due May 1, 2025 are for calendar year 2024.






Step 9: The screen below will appear, and an e-mail will be sent to the e-mail address provided:

Step 10: To re-access the form, click on either the link in the webpage or the link in the e-mail (step 9 above). If an e-mail does not appear within a few minutes, the filer should check their "spam" folder. Once the form is complete, click on the box circled below:

Step 11: The following screen will now appear; the filer should type their name and the last 4 digits of their social security number in the boxes circled below. The filer should enter their e-mail address and confirm it in the 2 boxes indicated with an arrow below. Once finished, the filer should click on the “Submit” button at the bottom of the screen:




