RULES AND REGULATIONS

| Ownership | All entries must be owned or leased by exhibitors who reside in Pennsylvania. If the animal is leased, an executed lease agreement must be completed by the entry deadline and be presented at check-in. No limited leases are permitted. All entries will be subject to the General Rules, Regulations & Health Requirements (link above); entry fees can be found there. |
| Stalling | Horses will be accepted subject to stall availability. If all horses cannot be accommodated due to space limitations, multiple-hitch exhibitors will only be permitted to bring one (1) spare horse. Every attempt will be made to accommodate stalling requests. Once stalls are assigned, exhibitors are NOT permitted to make changes unless reviewed and approved by the committee. Tack stalls will be limited based on the number of available stalls. |
| Show Requirements | All exhibitors are REQUIRED to show all horses in their respective halter classes. When selecting a halter class, horse ages are recognized as of December 31st of the year entries are due. If an exhibitor has more than two (2) eligible horses in a class, the exhibitor is required to show at least two (2) horses in that class. An exhibitor may show more than two (2) horses in any one (1) class but premiums will only be paid for the two (2) highest placings. |
| Health | A Certificate of Veterinary Inspection, Equine Infectious Anemia Testing, and Rabies vaccination are all required. Refer to the link above for additional Health Requirements. |
| Conduct | Any unsportsmanlike conduct or inappropriate behavior towards horses or people will result in disqualification of the exhibitor, forfeiture of ALL premiums, and the exhibitor will be required to leave the grounds immediately. Further action will be pending. The use of shock collars or other similar devices will result in disqualification from the show and forfeiture of ALL premiums. If the Show Chairs or Show Manager suspects the use of such a device, they may request to inspect any harness or piece of equipment. Refusal to allow inspection may result in disqualification from the show and forfeiture of ALL premiums. |
| Safety | The Farm Show Commission and Show Management reserves the right to address safety concerns due to episodes of equine disobedience resulting in a safety hazard. This may result in elimination from the class or show. Premiums will be forfeited if eliminated. |

| Failure to Exhibit | <p>Any exhibitor whose entries are accepted for the show and who for two (2) consecutive years fails to exhibit their animals shall be accepted for the following year only if extra space is available. A penalty of \$100 per animal will be assessed to the owner of each horse, dairy, or beef animal entered and not exhibited (shown) at the Farm Show. Entries cancelled on or before November 2, 2024, will permit a refund of entry fees with no penalty. Entry cancellations received on or before December 20, 2024, will cause forfeiture of entry fees without penalty. In extreme or unusual circumstances, a veterinarian excuse or a written appeal of the assessment of the penalty will be considered if received by the <u>Farm Show Manager</u> on or before January 14, 2025. Failure to pay the assessed penalty will result in disqualification from future Farm Show competitions. Substitutions are permissible with committee approval.</p> |
| Arrival | <p>Horses may begin arriving on Wednesday, January 1, 2025 until 9 p.m. All horses must be in place by 7:00 p.m. on Thursday, January 2, 2025, unless prior approval is given by the Committee Chair(s). The Equine Barn will be open to exhibitors for setup and displays on Monday, December 30, 2024, and Tuesday, December 31, 2024. All other areas will be available to exhibitors as stalls are set up.</p> |
| Check-In | <p>Check-in time for draft horses will be on Thursday, January 2, 2025, from 3:00 p.m. to 8:00 p.m. at the stalls. A driver's meeting will be held at 10:00 a.m. on Friday, January 3, 2025 in the Equine Barn. All additional (post) entries must be made no later than when the exhibitor's entries are checked in to the show. Paperwork needed for check-in: registration papers, leases, and card from veterinary check-in upon arrival to show grounds.</p> |
| Release | <p>Draft horses will be permitted to be released upon completion of the classes entered. Any exhibit removed prior to the listed times without Show Management approval will result in forfeiture of ALL premiums. All exhibitors must be out of the barns prior to 8:00 a.m. Monday, January 6, 2025. Stay all week horses must be removed from the facility no later than midnight on Saturday, January 11, 2025.</p> |
| Wrist Bands | <p>Exhibitors and helpers must wear wristbands for identification purposes when entering and leaving the arena and stable area on show day. Wristbands will be distributed at check-in.</p> |

| Attire | Dress shall be appropriate for the class. Blue jeans are not permitted in the ring for any reason , except in the western riding classes if worn with chaps, and in the feed scurry. Should you present in the ring with blue jeans, you will be asked to leave to change to suitable attire. |
| Classes and Show Order | Show management reserves the right to split, combine, or eliminate classes. A Final Show Order will be announced at Check-In. |
| Blood Testing | The first and second place pulling teams, plus one team selected at random, will be blood tested TO DETECT THE PRESENCE OF DISALLOWED DRUGS AND MEDICATIONS immediately following the respective contest. Equipoise and Lasix are NOT permitted AND WILL BE TESTED AT A ZERO TOLERANCE. Following the competition, the pull horses to be tested must go directly from the arena to the blood drawing location. Failure to submit horses immediately for testing will result in disqualification and forfeiture of all premiums. If a blood test is positive for either horse, all teams stabled at that address, regardless of ownership, shall be disqualified, forfeit all placings and premiums, and the driver(s), exhibitor(s), horses, and owner(s) shall be ineligible to compete the following year. Any driver and/or owner disqualified due to a positive drug test will be placed on probation the first year they return to competition. Their horses must be drug tested during this probationary period at the cost of the exhibitor. If the driver, owner, or exhibitor has a second violation, they will become ineligible to compete for five years. An additional vial of blood will be pulled to be retested at the expense of the owner (including shipping and lab cost) if the owner requests it. The request must be made to the administrative office within 48 hours of being notified that the blood test was positive. |
| Vehicles | Vehicles will be allowed into the building for hitching at the discretion of the Horse Committee. |
| Scoring | Scoring for the judging of all riding classes is as follows: Adult riding will be judged 40% equitation and 60% horse. Youth riding will be judged 60% equitation and 40% horse. The horse component will include performance, manners/suitability, soundness, and turnout. All riders are required to wear a helmet at all times while riding. FAILURE TO FOLLOW THIS RULE WILL RESULT IN DISQUALIFICATION AND POSSIBLE FORFEITURE OF ALL PREMIUMS. |

RULES AND REGULATIONS

Youth

Youth Drivers must be 8-19 years of age as of December 31, 2024, and must be accompanied by an adult. Age divisions to include Senior (16-19), Intermediate (12-15), and Junior (8-11). Adjustments may be made at the discretion of the show committee. Drivers/riders competing in any classes in Division 0005 – Draft Horse Hitched Classes, 0006 – Draft Horse Riding Classes, and 0007 – Draft Horse Pleasure Classes are ineligible to compete in any classes in Division 0008 – Youth Draft Horse Classes, with the exception of classes 169 - Barrel Racing and 195 - Feed Scurry, as the rules permit.

Exhibitors will be charged \$50 per panel for all panels removed without permission.

- 1. ENTRY:** Only horses representative of the mainstream draft horse breeds in the United States, that include but are not limited to, Belgian, Percheron, Clydesdale, Shire, Suffolk, and Spotted Draft, will be accepted. Horses not meeting draft standards will not be permitted to show. No light horses or crossbreeds with light horses are permitted. Crossbreeds based on acceptable draft horse breeds are permitted.
- 2.** All exhibitors are **REQUIRED** to show all horses in their respective halter classes. If an exhibitor has **more** than two eligible horses in a class, the exhibitor is required to show at least two horses in that class. An exhibitor may show more than two horses in any one class, but premiums will only be paid for the two highest placings.
- 3.** Halter classes, at the discretion of Show Management, may be combined, shown together, but placed separately. A horse must be shown in its respective breed class to be eligible to be shown in a group class(es).
- 4.** When selecting a halter class, horse ages are recognized as of December 31 of the year entries are due.

Halter Group Classes Defined

1. In all classes except get-of-sire and produce of mare, all animals must be owned by one (1) exhibitor. Mixed ownership within one (1) family not permitted.
2. Junior Get-of-Sire: To consist of two (2) animals, two (2) years and under, either sex, the get of one (1) sire.
3. Open Get-of-Sire: To consist of two (2) animals, any age, either sex, the get of one (1) sire. An animal can be shown only in one (1) get-of-sire class.
4. Produce of Mare: To consist of two (2) animals, either sex, the produce of one (1) mare.

1. ENTRY: Unless the class is breed specific, all classes are open to Belgian, Clydesdale, Percheron, Shire, and North American Spotted Draft Horses. A horse shown in a Draft Horse Hitched Class (Division 005) is ineligible to be shown in a Draft Horse Pleasure Class (Division 0007) with an exception made for Class 195 (Feed Scurry). **FAILURE TO FOLLOW THIS RULE MAY RESULT IN FORFEITURE OF ALL PREMIUMS.**

2. SCORING: Scoring for the judging of all hitch classes is as follows: 60% - Manners and performance; 20% - Conformation (appearance of horse or horses); and 20% - Appointments (wagons, harness).

3. In Classes 173 through 187, horse must be hitched to a suitable two (2)-wheeled cart. Each exhibitor is limited to one (1) entry in Classes 188 through 191.

4. No stallions are permitted in riding classes or youth cart classes.

5. A reasonable amount of time will be allowed for tack changes for Classes 173-187. The amount of time will be at the discretion of the judge.

6. Multiple hitch classes are limited to classic fifth wheel show wagon.

7. BORROWED HORSES: Two (2) horses may be borrowed for the Six (6) Horse Hitch class, and one horse may be borrowed for the Four (4) Horse Hitch class. Borrowed horses are not permitted in any other classes. Six (6) hitched horses may be comprised of ownership to include not more than two (2) exhibitors.

8. All multiple hitches must be made up of horses of the same breed.

9. CHAMPION HITCH EXHIBITOR: Placings from Classes 188, 189, 190, and 191 will be used to determine the Champion Hitch Exhibitor. Points will be awarded based on the number of entries shown in the class. All tiebreaker decisions will be made by the judge.

10. All Feed Scurry teams (horses and teamsters) will be limited to one attempt. Borrowing of horses and mixing of breeds will be permitted for this class. All drivers (teamsters) must be 14 years of age and older. Bale throwers may participate multiple times. This is a timed event.

ENTRY:** Only horses representative of the mainstream draft horse breeds in the United States, that include but are not limited to, Belgian, Percheron, Clydesdale, Shire, Suffolk, and Spotted Draft, will be accepted. Horses not meeting draft standards will not be permitted to show. No light horses or crossbreeds with light horses are permitted. Crossbreeds based on acceptable draft horse breeds are permitted.
- 2.** No scotch housing permitted. There are no shoeing requirements.
- 3. BORROWED HORSES:** Borrowing horses is not permitted.
- 4. SCORING:** Scoring for the judging of all hitch classes is as follows: 60% - Manners and performance; 20% - Conformation (appearance of horse or horses); and 20% - Appointments (wagons, harness).
- 5.** In Classes 210 and 211, horse must be hitched to a suitable two-wheeled cart.
- 6. WAGONS:** Any suitable four-wheel show vehicle will be permitted. All other non-standard show wagons must enter Class 217.
- 7. SHOW ORDER:** A final Show Order will be announced at Check-In.

ENTRY:** Only horses representative of the mainstream draft horse breeds in the United States, that include but are not limited to, Belgian, Percheron, Clydesdale, Shire, Suffolk, and Spotted Draft, will be accepted. Horses not meeting draft standards will not be permitted to show. No light horses or crossbreeds with light horses are permitted. Crossbreeds based on acceptable draft horse breeds are permitted.
- 2. SAFETY:** All riders are required to wear a helmet at all times while riding.
- 3.** Exhibitors must be 8-19 years of age as of December 31, 2024. Age divisions to include Senior (16-19), Intermediate (12-15), and Junior (8-11). Adjustments may be made at the discretion of the show committee.
- 4. YOUTH DECORATING:** Exhibitors will be allowed 30 minutes in the ring to roll a mane and tail only and present their horse to the judge. No showmanship will be required for this class.
- 5. YOUTH SHOWMANSHIP:** Youth to be judged on their ability to show a draft horse.
- 6.** No stallions are permitted in Youth classes.
- 7. DRIVERS:** Youth Drivers must be accompanied by an adult. Drivers/riders competing in any classes in Division 0005 – Draft Horse Hitched Classes, 0006 – Draft Horse Riding Classes, and 0007 – Draft Horse Pleasure Classes are ineligible to compete in any classes in Division 0008 – Youth Draft Horse Classes, with the exception of classes 169 - Barrel Racing and 195 - Feed Scurry, as the rules permit.
- 8. SCORING:** Scoring for the judging of all riding classes is as follows. Youth riding will be judged 60% equitation and 40% horse. The horse component will include performance, manners/suitability, soundness, and turnout.

BEST STALL DECORATION

Points will be awarded in four categories that will include: 1) Neatness of display and barn aisle area, 2) Educational value, 3) Courtesy and interaction of the exhibitors, 4) Display of farm/exhibitor names and location. Points will be awarded for neat, workmanlike tack room/barn aisle area. Extensive decoration is not necessary. The display should include some portion that would help educate the general public toward the use and ownership of the draft horse. Neatness and uniformity of the barn aisle will be rewarded. Courtesy and interaction with the viewing public is expected and will also be rewarded. No extra points will be awarded for displays that exceed what is needed for a workmanlike show operation. Judging will occur Friday-Sunday. A wooden plaque will be awarded to the winner.

| Health | <p>Horses competing in the Pulling Contest must be Coggins test negative for Equine Infectious Anemia within one year of the opening date to enter the show. The Coggins test report must be issued to the current owner and must list each horse with accurate identification including age, color, sex, and distinctive marks such as a tattoo, snip, blaze, stocking, etc. Thirty (30) days prior to the show, a Certificate of Veterinary Inspection is required. A current rabies vaccination administered by a licensed veterinarian is required, and rabies vaccination certificate or vaccination information must be included on the CVI. Horses found to be under the influence of drugs or medication, other than antibiotics or biologicals, shall be disqualified from the contest, forfeit all ribbons and premiums, and not be permitted to compete in the following Farm Show. Equipoise and Lasix are NOT permitted. A PDA vet shack card must be presented in order to weigh-in and compete. After weigh-in, this card must be visibly displayed at all times on stall doors. Any blood samples collected to detect foreign substances will be submitted to the Pennsylvania Animal Diagnostic System, Harrisburg, and subjected to those screening tests routinely employed to monitor racing horses.</p> |
| Weighing | <p>Horses must be weighed, with functional halters, the day of the contest strictly between 6:30 a.m.- 9:00 a.m. The scales will not remain open for official weighing past 9:00 a.m. Teamsters are requested to keep their team in their stall until notified. All teams must be stalled in the barn, no working off trailers. Owners and drivers must be at the mandatory meeting which will be at 11:30 am in the show office. Team and drivers have to be in the barn by 11:30 a.m. Pull is at 2 p.m.</p> |
| Weight Classes | <p>The Horse Pulling contest will consist of two weight classes: Overweight Class – 3,425 pounds and under Heavyweight Class – more than 3,425 pounds</p> <p>Teams will be permitted one official weight at the time called for official weighing. However, teams which weigh out of class will be permitted additional weighings. The last weighing prior to 9:00 a.m. will be the official weight. Teams must then enter the contest as they are weighed (with or without shoes.) Check weighing will be permitted on the morning of the contest.</p> <p>A horse may compete in only one weight class. A decision on the part of the exhibitor to move his team from the light class to the heavy class must be made before the completion of weigh-in.</p> |

| Harness | <p>Breakage of the harness during the pull will not constitute a trial. However, the driver has the option of counting the trial and the distance will then be credited to the team. In the event of harness breakage, the team will move to the end of the line in rotation. Open bridles are permitted. Horses shall not be tied together by neckyoke, straps, ropes, or in any other way. They are to be held together only by the regular lines used in driving. | Trials | <p>Each team will be allowed three (3) trials at each weight. All teams must take all trials in the order called. However, if the team fails to pull the required distance of twenty-seven- and one-half feet (27 ½') they can opt to unhook or stayed hooked but must pull again within a two-minute time period. Teams must make an attempt on the first or second pull to move the sled in order to get a third pull.</p> <p>Once a teamster is called, he will be permitted three minutes to bring his team to the sled and start his first trial; however, horses may not leave the box until instructed by the Box Judge. If he does not have a full pull the teamster will be permitted two minutes before starting his second trial. If he does not complete a full pull the teamster will be allowed three additional minutes before attempting his third trial. Equipoise and Lasix are NOT permitted AND WILL BE TESTED AT A ZERO TOLERANCE. Following the competition, the pull horses to be tested must go directly from the arena to the blood drawing location. Failure to submit horses immediately for testing will result in disqualification and forfeiture of all premiums. If a blood test is positive for either horse, all teams stabled at that address, regardless of ownership, shall be disqualified, forfeit all placings and premiums, and the driver(s), exhibitor(s), horses, and owner(s) shall be ineligible to compete the following year. The names of the driver(s), exhibitor(s), horses, and owner(s) will be sent to all County Extension offices. Any driver and/or owner disqualified due to a positive drug test will be placed upon probation the first year they return to competition. Their horses must be drug tested during this probationary period at the cost of the exhibitor. If the driver, owner, or exhibitor has a second violation, they will become ineligible to compete for five years. An additional vial of blood will be pulled to be retested at the expense of the owner (including shipping and lab cost) if the owner requests it. The request has to be made to the administrative office within 48 hours of being notified that the blood test was positive.</p> |
| Protest | <p>Horses are also subject to blood testing if a protest is filed by a competing driver. The complaint, accompanied by a \$100.00 deposit, must be filed in writing to the Superintendent before the horses leave the arena. If the blood test is positive for the presence of any drugs or medication, other than antibiotics or biologicals, the team shall be disqualified, will forfeit any ribbons and premiums, and the driver, exhibitor, horses, and owner shall be ineligible to compete the following year. The identity of the complainant will not be revealed to the accused driver or owner. The \$100.00 deposit will be returned to the complainant only if the blood samples are positive.</p> |
| Setting Farm Show Record | <p>If more than one overweight team crosses 10,000 lbs, the new load will be 10,250 lbs. If more than one heavyweight team crosses 11,300 lbs, the new load will be 11,550 lbs. If only one team crosses the record load, then only an additional 25 lbs will be added. If only one team crosses the record load, the teamster may set the sled for the first, second, and third trials. 1. There will be two classes: Overweight for teams weighing 3,425 pounds and under and heavyweight for teams weighing more than 3,425 pounds.
2. **ALL ENTRIES MUST BE MADE ONLINE.** Entries close December 3, 2024. An entry fee of \$40 per team must accompany the entry.
3. **FAILURE TO EXHIBIT:** Any exhibitor whose entries are accepted for the show and who for two consecutive years fails to exhibit his/her animals shall be accepted for the following year only if extra space is available. A penalty of \$100 will be assessed to the owner of each team entered and not exhibited (shown) at the Farm Show. Entries cancelled on or before December 3, 2024, will permit a refund of entry fees with no penalty. Entry cancellations received on or before December 22, 2024, will cause forfeiture of entry fees without penalty. In **extreme or unusual circumstances**, a veterinarian excuse or a written appeal of the assessment of the penalty will be considered if received by the ***Farm Show Manager*** on or before January 14, 2025. Failure to pay the assessed penalty will result in disqualification from future Farm Show competitions. Substitutions are permissible with committee approval.
4. Stalls will be available beginning at 10:00 a.m. on Monday, January 6, 2025. All horses must be in the Equine Barn by 10:00 a.m. on Tuesday, January 7, 2025 for mandatory weigh-in, which will be from 6:30 a.m. to 9:00 a.m. The mandated meeting will be at 11:30 am in the show office. No working off trailers will be permitted. Horses must depart by 8:00 a.m. on Wednesday, January 8, 2025.
5. Exhibitors with only one team or teams of questionable weight should make one entry per team. The official weighing, with halters on, will determine the class in which the team is eligible to pull.
6. Horses may pull in one class only and only one division (i.e. horses in this pull cannot pull in the Farm Class Division).
7. A sled will be used in the contest.

HORSE PULLING CONTEST

8. The contest will start at approximately 2:00 p.m. on Tuesday, January 7, 2025, with the overweight division first.

9. The contest will be conducted under Farm Show rules. Detailed rules will be furnished to each entry. Competition is limited to teams owned by contestants residing in Pennsylvania. Drivers must also be Pennsylvania residents.

10. ENTRIES: The contest is limited to a total of 40 teams. Entries must be made in the proper class. The first 20 overweight and the first 20 heavyweight entries will be accepted based upon date and time of online entry. If one class fails to reach a total of 20 entries, then additional entries will be accepted in the other class up to the total of 40 teams.

11. STABLING: Teams accepted will be stabled in the Farm Show Complex. Teams must use their assigned stall. A limited number of stalls will be available for those teams who need to stay overnight after the contest. Check with Show Management about availability.

12. The Farm Show Commission and Show Management will make the final decision on all rules.

2. **ALL ENTRIES MUST BE MADE ONLINE.** An entry fee of \$40.00 per team must accompany the entry.
3. **FAILURE TO EXHIBIT:** Any exhibitor whose entries are accepted for the show and who for two consecutive years fails to exhibit his/her animals shall be accepted for the following year only if extra space is available. A penalty of \$100 will be assessed to the owner of each team entered and not exhibited (shown) at the Farm Show. Entries cancelled on or before December 3, 2024, will permit a refund of entry fees with no penalty. Entry cancellations received on or before December 20, 2024, will cause forfeiture of entry fees without penalty. In **extreme or unusual circumstances**, a veterinarian excuse or a written appeal of the assessment of the penalty will be considered if received by the **Farm Show Manager** on or before January 14, 2025. Failure to pay the assessed penalty will result in disqualification from future Farm Show competitions. Substitutions are permissible with committee approval.
4. Classes: Lightweight Teams - up to 1,825 pounds; Mediumweight Teams - 1,826-2,125 pounds; Heavyweight Teams - 2,126- 2,275 pounds.
5. Entries will be accepted to a maximum of 27 teams. The official weighing with halters on will determine in which class the team is eligible to pull.
6. **OWNERSHIP:** Competition is limited to teams owned by contestants residing in Pennsylvania. Drivers must also be Pennsylvania residents.

3. **FAILURE TO EXHIBIT:** Any exhibitor whose entries are accepted for the show and who for two consecutive years fails to exhibit his/her animals shall be accepted for the following year only if extra space is available. A penalty of \$100 will be assessed to the owner of each team entered and not exhibited (shown) at the Farm Show. Entries cancelled on or before December 3, 2024, will permit a refund of entry fees with no penalty. Entry cancellations received on or before December 20, 2024, will cause forfeiture of entry fees without penalty. In **extreme or unusual circumstances**, a veterinarian excuse or a written appeal of the assessment of the penalty will be considered if received by the **Farm Show Manager** on or before January 14, 2025. Failure to pay the assessed penalty will result in disqualification from future Farm Show competitions. Substitutions are permissible with committee approval.
4. Mini horses and mini mules are eligible to compete. Teams will compete by height in one of three classes: 34-inch, 36-inch, 38-inch.
5. Entries will be accepted to a maximum of 27 teams. If the maximum of 27 teams is not reached by entry deadline, additional teams will be accepted, based on earliest postmark, up to a maximum of 27 teams for the contest.
6. **OWNERSHIP:** Competition is limited to teams owned by contestants residing in Pennsylvania. Drivers must also be Pennsylvania residents. Each owner is limited to three teams per class.
7. Stalls will be available beginning at 10:00 a.m. on Monday, January 6, 2025. Teams and Minis are required to be in the barn by 6:30 a.m. for measuring and mandated meeting after measuring. No working off trailers will be permitted. Minis must depart by 8:00 a.m. on Wednesday, January 8, 2025.

8. RULES: The contest will be conducted under normal mini pulling rules. Detailed rules will be furnished to each entry.

9. Teams will be measured from 6:30 a.m.-7:30 a.m. and a meeting (open to drivers, young drivers with one parent, Farm Show employees, and Superintendent only) will be held at 7:30 a.m. in the Horse Show Office on January 7, 2025.

10. STABLING: Teams accepted will be stabled in the Farm Show Complex. Teams must use their assigned stall. Teams will share a stall. 11. A sled will be used for the contest and the extender will be used on the hitch.

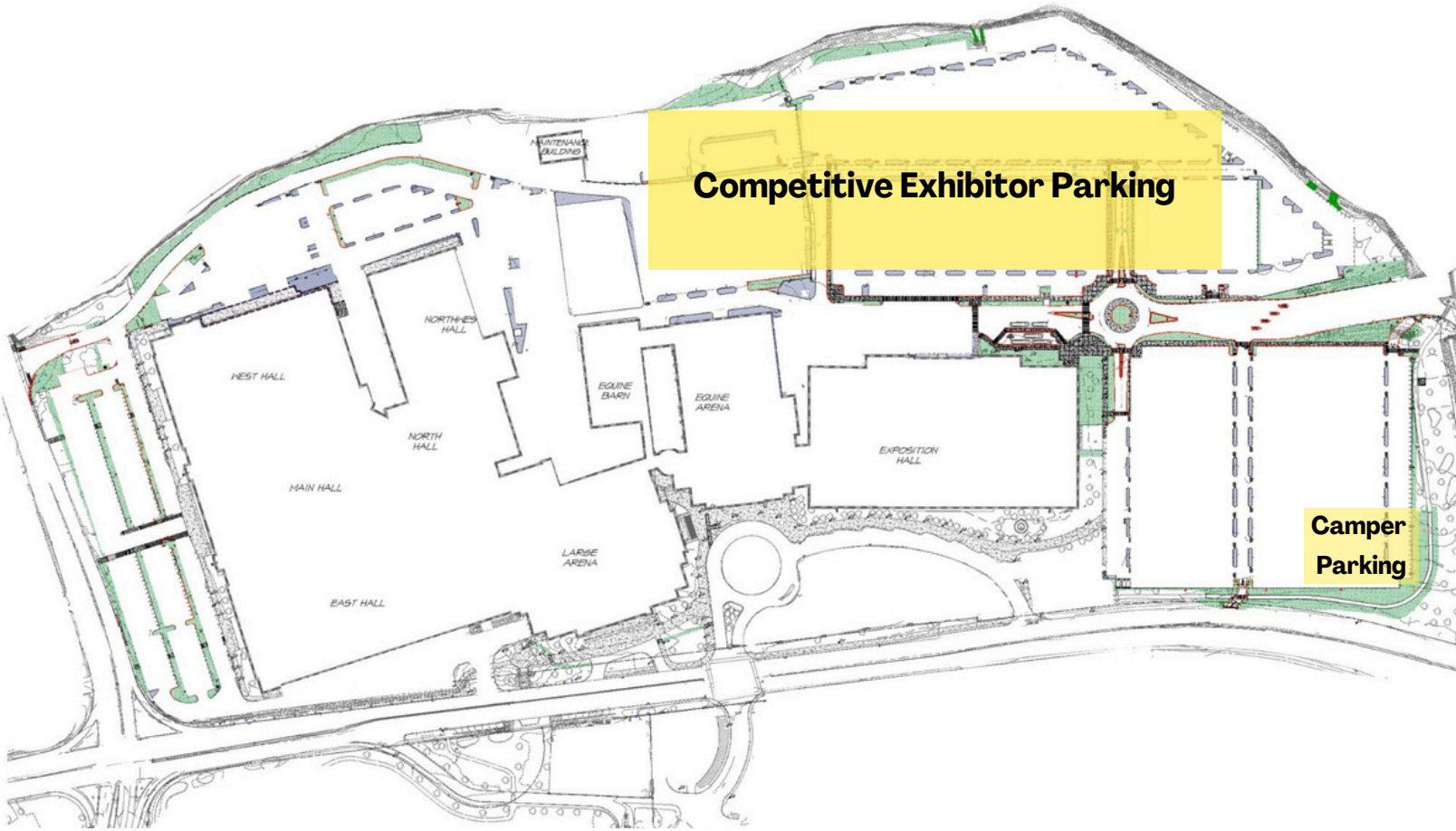

FIRE REGULATIONS

1. All exit corridors and emergency exits must be kept clear; no partial blocking will be permitted.
2. All fire alarm pull stations must be kept clear.
3. Fire extinguishers may not be covered by any drapes or hidden by any type of displays.
4. No motorized camping units or vehicles may contain more than one (1) gallon of fuel while on display.
5. All pressurized fuel tanks may be drained.
6. All fuel fills must be locked and fuel caps must be taped closed with duct tape.
7. Any living trees and shrubs are acceptable as long as the shrubbery is individually bagged and baled.
8. Artificial trees and shrubbery must be treated with a flame proofing material. The fire official may request certification of flame proofing.
9. Any type of mulch materials must be treated with a flame proofing material or watered daily. If treated with a flame proofing material, certification may be requested by the fire official.
10. Smoking is prohibited in the Pennsylvania Farm Show Complex & Expo Center.
11. No open flames, fires or burning of any kind will be permitted within the Complex. No exterior burning is allowed unless the Department of Environmental Protection and the Bureau of Fire grant permission.
12. Vendors setting up tents, canopies and membrane covering must provide fire department with fire rating of material. Vendors must also provide any required portable fire extinguishers as needed.
13. Outside propane tanks shall be protected by posts or other approved physical barriers (Jersey barriers).
14. Extinguishers need to be visible, accessible and located in a conspicuous location where they will be readily accessible and immediately available for uses. These locations shall be along normal paths of travel.
15. Doors shall never be blocked or tied off.
16. The Fire Prevention Code of Harrisburg will be strictly enforced.

EMERGENCY PREPAREDNESS TIPS

EARLY DETECTION

- Early detection is the most effective way to prevent emergencies or lessen their impacts.
- Vendors and exhibitors will likely be the first to witness, experience, or report incidents.
- You can be the difference in preventing something harmful from happening.
- To report any type of threat or emergency incident, notify the PA State Police Command Post.

BOMB THREATS

- Threats can be made in person, by phone, or in written message.
- Collect as much detailed information as possible about the threat (when, why, how, exact wording of threat, type of voice, personal appearance, clothing description, name, gender, phone number, physical address).
- It is especially important to know the perpetrator's timeline for activation of the device (when will it occur?).
- Immediately report the threat to the State Police Command Post.
- Authorities will investigate the threat and make the proper decisions accordingly in coordination with facility management.

LOST CHILDREN

- Be sure to get the full name of the lost child and keep them safe with you. Notify the Farm Show security desk or closest security/law enforcement team. PSP or Farm Show staff will help to reunite lost children with loved ones.

SHELTER IN PLACE

- Although rare, there could be incidents that occur outside the facility that could put people at risk (chemical fire, very severe weather). In these instances, a shelter-in-place plan will be implemented for the welfare of all occupants.

SUSPICIOUS OBJECT

- Do not touch or disturb the object.
- Maintain a safe distance from the object and attempt to isolate the area.
- Notify the State Police Command Post with a description and location of the object.

SUSPICIOUS PERSON

- Observe the circumstances and behavior of the suspicious activity.
- Notify the State Police Command Post and provide as much detail as possible.
- Details about the person should include direction of travel, appearance, height and weight, build, clothing, speech, and anything about the behavior that indicates suspicion.

FLOODING

- Facility management will attempt to mitigate the effects of flooding and natural disasters before they happen and will work with all show vendors during this type of event.
- The Maclay and West parking lots are susceptible to flash flooding.
- Avoid contact with flood water.
- If major interstates or surrounding roads are being closed, facility management will make announcements accordingly.

MEDICAL EMERGENCY

- Notify the State Police Command Post and they will dispatch emergency medical services to the location.
- Describe the nature and severity of the medical incident and location of the victim.
- Do not attempt to move the person unless you are a trained medical responder.
- Stay with the victim and seek help from others if necessary.
- If rendering aid due to your training, be careful not to expose yourself to hazards such as fire, electricity, hazardous materials, or blood borne pathogens

FIRE & EVACUATION

- If you see a fire, activate the nearest alarm or notify the Farm Show Security Desk.
- The City of Harrisburg Bureau of Fire will respond to the alarm.
- When the building evacuation alarm is activated, leave by the closest and safest exit and alert others to do the same.
- Quickly take all personal belongings.
- Please listen to the instructions of the PA system announcements, Farm Show Complex employees, or responders.
- Do not use elevators!
- The facility is equipped with sprinklers and ABC fire extinguishers.
- Once outside, move a safe distance from the building.
- Do not return to an evacuated building until the 'all-clear' sign is provided by the Fire Chief, a Police Officer, or any other official first responder.
- Do not operate cell phones during an evacuation until the 'all-clear' is given

VIOLENT BEHAVIOR

- Your safety comes first. Use your best judgement to preserve your life.
- Report any physical abuse to the State Police Command Post.
- If there's an active shooter in the facility but not in your area, evacuate the facility and find safety.
- If the active shooter is near your area and preventing your escape, go to a room that can be lock or barricaded or hide and remain silent.
- If the shooter knows you are there but you feel you can flee, quickly evacuate the area.
- If you feel like fleeing is not possible, you can either confront, or attempt to overpower the person.
- If there is a shooter, messages regarding the known location of that person may be broadcast over the PA System.
