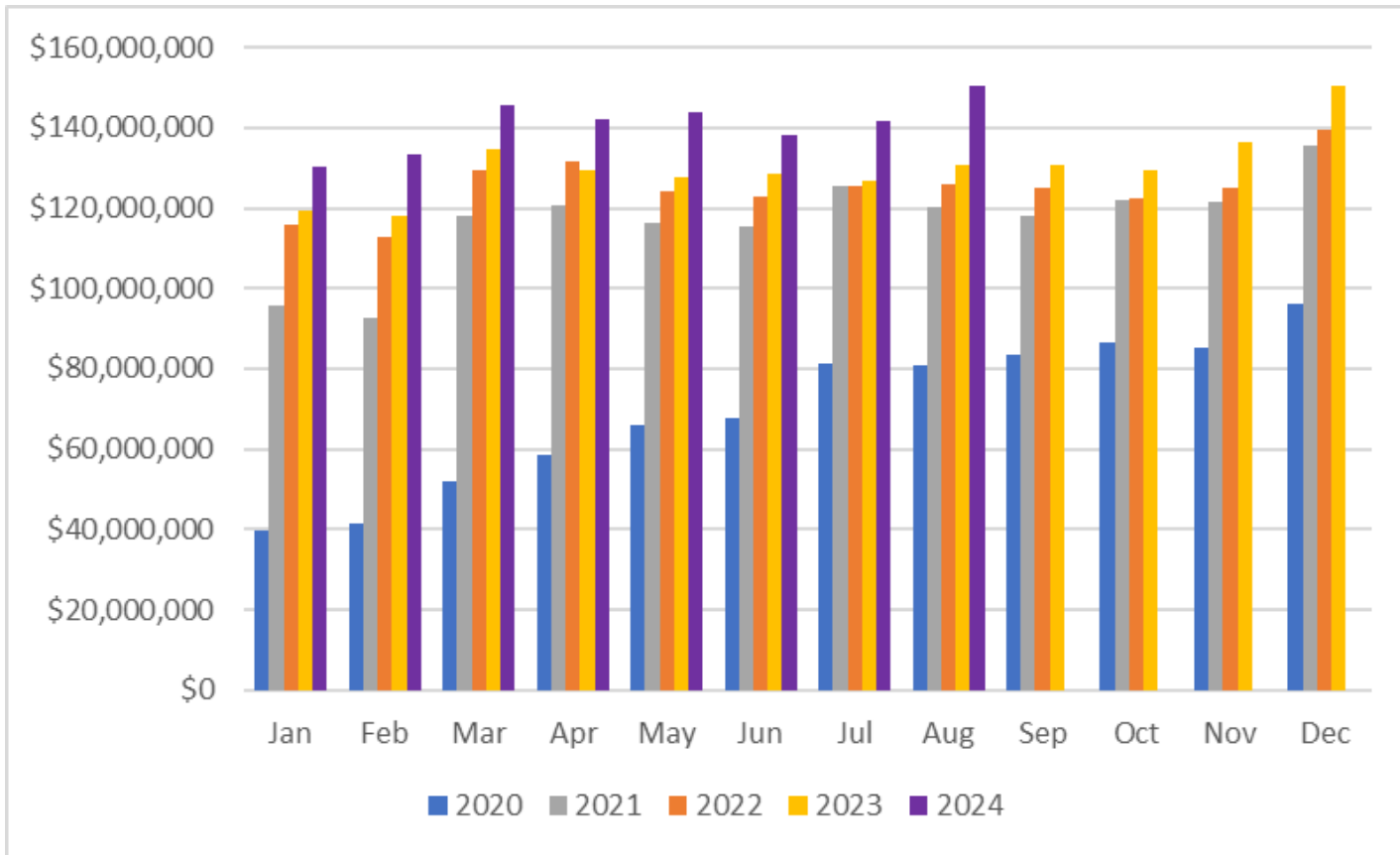

## Dispensary Sales by Month Since Jan 2020

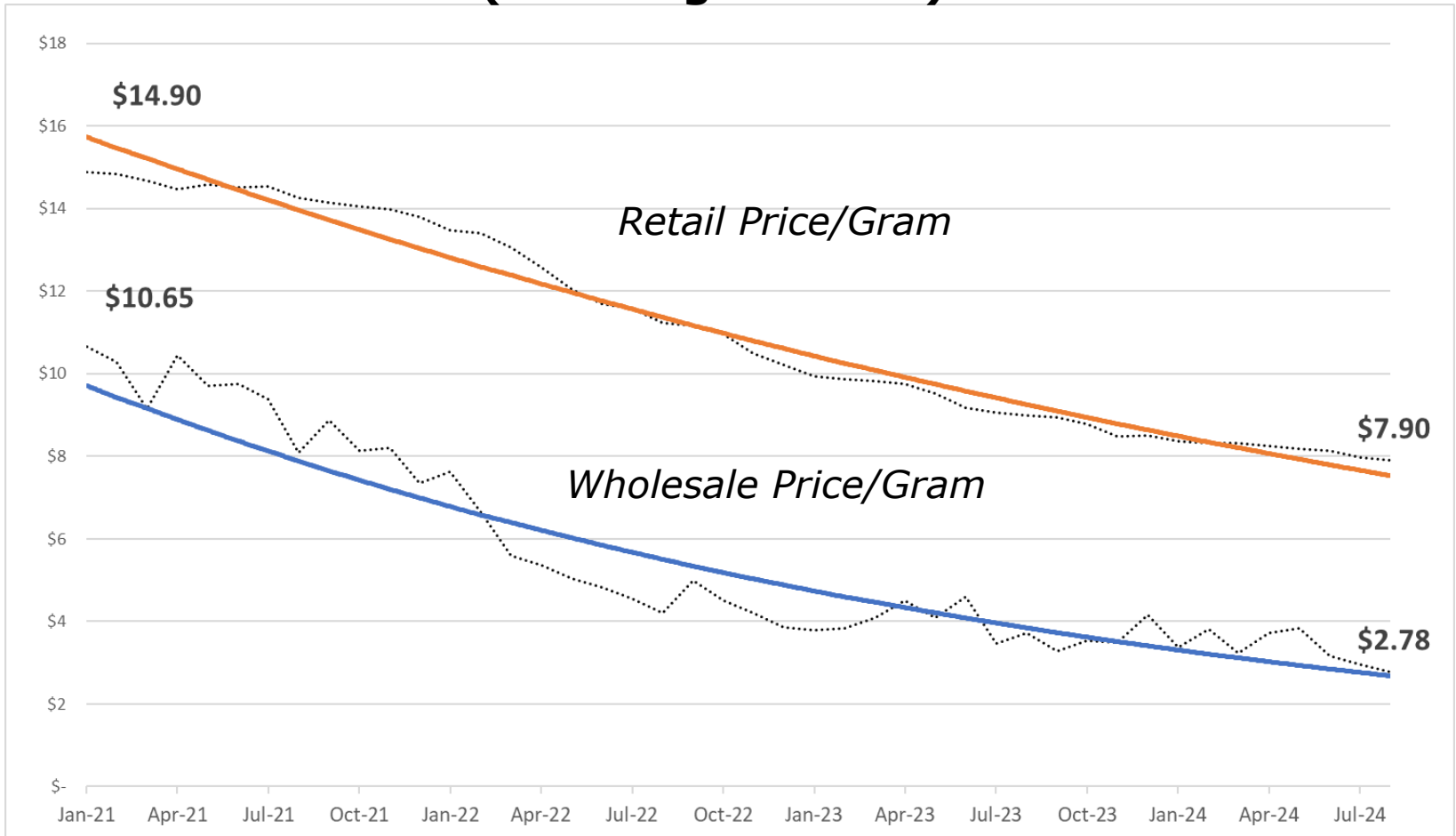


*\$6.5 Billion Sales Program-to-Date*
