Pledge of Allegiance to the Flag

Chairman Holden made an opening statement thanking everyone for their continued cooperation and understanding as the PLCB is dealing with COVID-19 and the need to meet in this telephonic fashion. Chairman Holden stated that we still face a very serious health crisis. As of today, approximately 115,000 Pennsylvanians have been infected and sadly, approximately 7,232 have passed away.

A. Motion to approve previous Board Meeting Minutes of the July 15, 2020 meeting,

Board Decision: Unanimously agreed (3-0 vote) to approve previous Board Minutes.

B. Announcement by the Chairman for Ratification of a Board Action.

Chief Counsel Rodrigo Diaz stated that Advisory Notice No. 26, which provides guidance to the alcoholic beverage industry to follow during the COVID-19 emergency, had been updated due to the Governor's guidance being changed in between Board Meetings. The PLCB had to update its Advisory Notice No. 26 in order to be consistent with the Governor's Order to mitigate.

Chief Counsel Diaz stated Advisory Notice No. 27 had been updated due to the Board waiving numerous fees and waiving the license safekeeping requirement to alleviate some of the issues that licensees are dealing with right now. License renewals are filed

with the PLCB in the beginning of each month, and therefore, the PLCB wanted to get this update out before licensees began filing for their renewals.

The following Board Action approved on July 28, 2020 was decided by Notational Voting after the adjournment of the Board's last public meeting on July 15, 2020.

Chairman Holden, Member Negra and Member Isenhour agreed (3-0 vote) to adopt Advisory Notice No. 27 and Advisory Notice No. 26 (3rd Revision).

PUBLIC COMMENT ON AGENDA ITEMS

The Board has reserved 10 minutes for Public Comment on printed agenda items.

The teleconference moderator confirmed that there were no callers with comments.

NEW BUSINESS

(1) Lower Paxton Township Case No. 20-NE-07 Municipal Petition for Exemption from Liquor Code Statute Regarding Amplified Sound

Chief Counsel Rodrigo Diaz stated this is a first request by the municipality for exemption from the Liquor Code statute regarding amplified noise. Municipalities can exempt some or all of the municipality as long as they are willing to enforce their own noise ordinance by statute. The PLCB is required to have a hearing in the affected area to allow the people who live there an opportunity to protest or testify in support. A hearing was held, and no protests were received. Typically, the Board approves a first request for a one-year period.

Municipal Petition for Exemption from Liquor Code Statute Regarding Amplified Sound Chief Counsel Rodrigo Diaz stated this is the Borough of New Bethlehem's first request for noise exemption. A public hearing was held in the affected area and no protests were received. First requests are usually approved for a one-year period.

Commonwealth Court Appeal

License No. R-18574 LID 80974 Docket No. 2019-C-3181 (Lehigh County)

Chief Counsel Rodrigo Diaz stated the question is whether the Board wishes to appeal to Commonwealth Court a decision made by the Lehigh County Court of Common Pleas. The PLCB had received an application regarding a license in safekeeping due to an issue regarding the licensed area. The room in question is essentially a utility room, and was not being used as a serving area due to numerous concerns about it. A hearing was held and ultimately the Board decided to not remove the license from safekeeping because it was found that it was not really a restaurant.

The Court of Common Pleas disagreed. The Court focused on the fact that the room met the statutory requirements regarding the amount of square footage and that there were a sufficient number of chairs and tables. There is an expired health permit there now, so the Judge made his order conditional on the renewal of that permit and the Judge was not concerned about the fact that the room in question is really a utility room.

The question is whether to appeal. The Commonwealth Court is going to defer to Common Pleas as to the factual determination and the law, so it is the Office of Chief Counsel's recommendation not to appeal due to the unlikelihood that the PLCB would prevail, notwithstanding the fact that the room in question is a utility room.

Request for Rescission of Conditional Licensing Agreement Chief Counsel Rodrigo Diaz stated this was a licensee that approximately ten years ago wound up in the PLCB nuisance bar program mostly due to entertainment violations. The PLCB and the licensee entered into a conditional licensing agreement, which was amended five years ago. The licensee had reached out to the PLCB to state that there have not been any problems and that they have changed their business model, thus asking to not adhere to the conditions in the conditional licensing agreement any longer. The establishment had not been a problem licensee in the last five years and the Board, under its current conditional licensing agreement program, would allow the conditional licensing agreement to end after a couple of years if a licensee had proven to not be a problem.

Board Member Negra stated that Chief Counsel Diaz described the new system, but clarified that any licensee under a conditional licensing agreement can request a rescission of their conditional licensing agreement if there are no issues. Even if there are issues, the licensee can still ask for a rescission. Any licensee at any time can ask for a rescission.

Chief Counsel Diaz stated that is correct and restated that any licensee at any time can ask for a rescission. This licensee had been operating with no problems for at least the last five years.

Director of Finance, Michael Demko, stated this is a \$50,000 annual support payment for this fiscal year. This item is for the e-grants system which was implemented for the PLCB's e-grants that are issued. This comes from the Department of Community and Economic Development. Last year's cost for implementing the system was \$200,000.

Board Member Negra asked Director of Regulatory Affairs, Tisha Albert, if she likes the system.

Ms. Albert stated she does, and it has been beneficial for staff in saving time since everything goes through the workflow electronically.

CITIZEN COMMENT/BUSINESS FROM THE FLOOR

Madison Foley asked the Board to restate their decision on two separate Bureau of Licensing agenda items; Half-Time Good Time and Jet-Set Restaurant.

Chairman Holden stated that the Board decided on nonrenewal for Jet-Set and the Half-Time Good Time renewal was approved due to a conditional licensing agreement being signed.

Board Member Negra congratulated Mr. Mooney and hoped that Mr. Mooney will get to relax and watch Red Sox games in his retirement. Board Member Negra stated that life is short, and it can change with the drop of a hat, so enjoy it and have a good time from this point on. Board Member Negra stated that he has worked with Mr. Mooney for six years, a part of the original breakfast club, and that he could not have done his job anywhere near the way he had without Mr. Mooney's knowledge and guidance. Board Member Negra stated that it has been a pleasure to watch Mr. Mooney move from Director of Retail Operations to Chief Operating Officer to Chief Executive Officer, and that there had not been a normal day since Mr. Mooney became Executive Director. Board Member Negra stated that Mr. Mooney had guided the PLCB through a lot of big changes that came about due to the passing of Act 39, in addition to the changes regarding the general fund and the operations. Board Member Negra stated that he can tell how much Mr. Mooney loves people, especially during the onboarding meetings with the new employees.
