Training Director's Corner

Use of Force/Control Tactics

As a reminder, Use of Force and Control Tactics is required annually and must be completed through the police department. Departments are required to use a MPOETC-approved Control Tactics instructor for the annual training.

In 2022, the MPOETC Commission approved changes to the control tactics program for municipal officers. At that time, instructors who had completed an instructor development course and an approved control tactics instructor course were granted status as "Temporary MIST Instructors" with the intent of training department officers. In 2023, the temporary MIST instructors were "grandfathered" in and permitted to continue training department personnel. Since that time, a considerable amount of "temporary instructors" have been approved as department level instructors.

If you are still operating as a Temporary MIST Instructor and would like to be approved as a certified instructor, simply submit the MPO-239 form (Certified Law Enforcement Control Tactics Instructor) and a copy of your previous training certificates from the MPOETC approved control tactics instructor course you attended. Submit these documents to ra-mpotraining@pa.gov for review and approval. You can also submit any questions regarding the control tactics program to the same email address.

Lastly, the control tactics program is currently undergoing a full review by MPOETC, and updates will be published once the review is completed.

Quarterly Legal Updates

The Commission recognizes that both statutes and case law can change frequently and throughout the year. While officers take mandatory Legal Update training, many times the officers would have benefitted from knowing about the changes when they happened rather than waiting months to attend the class. To help reduce the time it takes for officers to hear about recent changes to the law, the Commission's quarterly newsletter now includes a synopsis of the most significant recent changes.

DUI Actual Physical Control

Bold v. [PennDOT], Pa. , A.3d (8/20/204)

On January 25, 2020, Lower Allen Township Police Officer Thomas Gelnett found Thomas E. Bold, Jr., unconscious behind the wheel of a car that was legally parked in a mall parking lot near a bar. It was a dark and cold evening. The car's engine was running and the headlights were on. When roused, Bold appeared to be very intoxicated. He admitted to drinking at the bar nearby, and he had explained that he had intended to sleep in his car until he was fit to drive home safely and legally.

Bold was arrested for driving under the influence, ("DUI"), and taken into custody. Bold was driven to a nearby medical facility, where Bold refused to consent to a blood test. In keeping with §1547, Bold was notified that his driving license would be suspended due to the refusal.

Issue: Did the officer have reasonable grounds to believe that the defendant was in actual physical control of the vehicle?

Ruling: **No.** The officer in question admitted he had no reason to suspect that the defendant had driven his vehicle while intoxicated.

Significance: In determining whether an officer had reasonable grounds to believe that a motorist was in actual physical control of a vehicle, the court must consider the totality of the circumstances, including the location of the vehicle, whether the engine was running and whether there was other evidence indicating that the motorist had driven the vehicle at some point prior to the arrival of the police.

Highlights from the September 2024 Commission Meeting

On September 25 and 26, 2024, the Municipal Police Officers' Education and Training Commission held its regular quarterly meeting at the Omni Bedford Springs Resort in Bedford. On Wednesday afternoon, September 25, 2024, the Commissioners held committee meetings to discuss the business of the Commission. On Thursday morning, September 26, 2024, the Commissioners met in an Executive Committee meeting, which was followed by the formal meeting of the full Commission, where they took the following actions:

• The Commission revoked the certifications of five officers for convictions of the following disqualifying offenses: Theft Concerning Programs Receiving Federal Funds, Theft by Unlawful Taking or Disposition, Official Oppression, Stalking, Transporting an Illegal Alien, and Conspiracy to Distribute and Possess with Intent to Distribute Cocaine, Marijuana, 400 Grams or More of Fentanyl, and 500 Grams or More of Methamphetamine.

• The training staff provided an update on cadet enrollments throughout the Commonwealth.

• The Commission approved the following Mandatory In-Service Training courses for 2026: Legal Updates, Crisis Intervention Training, Trauma Informed Policing and Responding to Child Abuse Allegations.

• The Commission approved the Certification Test and Partial Waiver Test score to be lowered from 72% to 70% for a passing score.

• The Commission approved the relocation for IUP Police Academy satellite campus from Pittsburgh Technical College that is now closed to the CNX Corporation building in Canonsburg, Washington County.

• Allegheny County Housing Authority Chief Michael Vogel, who is also the President of the Chiefs of Police Association, attended the meeting and thanked MPOETC for all the support that is provided throughout the Commonwealth from the MPOETC staff.

• Former MPOETC Commission member Kristen Denne, who is now the Municipal Manager for Bethel Park, attended the meeting and received a letter of recognition and a plaque from her time on the Commission from PSP Commissioner Christopher Paris.

• Commission Counsel Kevin Klinkner has been promoted to Deputy General Counsel and will be leaving the MPOETC Commission position. Commissioner Paris presented Attorney Klinkner with a letter of recognition and a plaque for his time as Commission Counsel.

Announcement from the Department of Justice

Law enforcement plays a critical role in our response to elder abuse. Interviewing victims and witnesses is an important aspect of an investigation, and yet there has been little training available on forensic interviewing with older adults.

The 2-Day SAFE Training is designed for elder justice professionals to improve their communication and interviewing skills with older victims of abuse. The course covers the basics of elder abuse, its dynamics, and the SAFE Model of interviewing, with interactive practice sessions included. Communities interested in hosting the training:

- Must recruit 50 participants from law enforcement and related fields (e.g., Adult Protective Services, Medicaid Fraud Control Units)
- Provide a suitable venue with a space large enough to accomodate 50 seats and audio/video equipment for the trainers (e.g., PPT projection, internet).
