PART I.

This RFP was issued pursuant to Executive Order 2015-2 dated January 20, 2015, and in accordance with Section 518 of the Commonwealth Procurement Code, 62 Pa.C.S. § 518, and Part III Chapter 8 of the Department of General Services (DGS) Procurement Handbook.

The Issuing Office designated to conduct this procurement has completed its evaluation. As further described below, the following law firms are being recommended for award of legal services contracts:

Stradley Ronon Stevens & Young, LLP (prime counsel) Cozen O'Connor (conflict counsel)

A. PUBLIC NOTICE: Public notice of the RFP was posted on both the PA eMarketplace website and the Office of General Counsel's website on **August 13, 2024.**

- B. EVALUATION COMMITTEE: An evaluation committee was established consisting of agency representatives from the **Pennsylvania Department of Insurance and the Governor's Office of General Counsel.**
- C. ADDENDA TO THE RFP: Potential offerors were given the opportunity in accordance with Section I-8 of the RFP to submit questions concerning the procurement to the Issuing Office. The official responses to the questions were incorporated into the RFP by addenda per Section I-9 of the RFP.

PART III.

- A. CRITERIA: The relative importance of the major evaluation criteria established prior to opening the proposals consisted of **technical 75% and cost 25%**.
- B. PROPOSALS: A total of **three** (3) proposals were received on or before the due date of **September 4, 2024**. No proposals were received late.

C. RESULTS:

- 1. The evaluation committee reported the following results of its evaluation to the Issuing Office:
- 2. As indicated in the Initial Scoring, all of the offeror's technical submittals received at least **75%** of the available technical points required in order to be eligible to be considered for award.
- 3. INITIAL SCORING: The overall scoring for this procurement concluded as follows:

PART IV.

RECOMMENDATION: As the Issuing Officer, I recommend Stradley Ronon Stevens & Young, LLP and Cozen O'Connor be awarded contracts for legal services. The term of the contracts will be one year with two (2) additional one (1) year renewals. The Department of Insurance will allocate the legal services set forth in the resulting contracts among the selected law firms. Due to the urgent need for legal services, the Department of Insurance is seeking Stradley Ronon Stevens & Young, LLP and Cozen O'Connor to begin work immediately.
