You may be entitled to counsel from the Public Defender's Office at no cost. The Administrative Remedies Form and the names and addresses of all Chief Public Defenders in the Commonwealth are available upon request from the SCI Parole Office. Any request for a public defender should be sent directly to the Public Defender's office in the county where you currently reside.
