Enhancing Emotional Intelligence: A Key to Successful Leadership

In today's demanding workplace, emotional intelligence (EQ) is considered one of the most crucial skills. EQ not only benefits your professional and personal life but also deepens your self-awareness. For those helping professions, a high level of emotional intelligence is particularly vital. Without it, employees might ignore, escape from, or numb their emotions, leading to long-term medical and mental health issues, as well as problems both at work and home.

The mission of the Huntingdon County Endangered and At-Risk Youth Response Team (HEART) is to create an early warning "handle with care" alert between Law Enforcement, Children and Youth Services, and local school districts to provide timely and valuable information about concerned youth that otherwise would go undetected and unreported. HEART works to collaboratively combine the expertise and resources of multiple professionals, agencies, and communities to improve interventions for children and families.

Informed Decision-Making Through Behavioral Health Screening and Risk Assessment in Pennsylvania's Juvenile Justice System

In Pennsylvania, juvenile probation departments use screens to identify youth in need of behavioral health assessments and/or services at the intake conference. Data shows youth who screen in for trauma reactions and score high in clinically significant ranges for broader behavioral health concerns tend to score higher in a risk domain that is highly correlated with reoffending. Our hypothesis is youth charged with school-related offenses will follow this trend.

In 2020, Bucks County launched its first Co-Responder Program at the Bensalem PD. Since then, it has expanded to 24 PDs. This presentation will focus on the implementation/expansion of the CR program in Bucks County and feature a case study from Falls Township PD (who adopted the model in its early stages) in hopes of inspiring attendees to explore CR initiatives to improve public safety, enhance MH outcomes, and better navigate complex social issues.

Examining the Intersection of Crisis Response and the Justice System in Pennsylvania: Lessons Learned from Listening Sessions with Key Stakeholders

Supported by Pennsylvania's Byrne State Crisis Intervention Program (SCIP), the Pennsylvania Commission on Crime and Delinquency (PCCD), in partnership with The Council of State Governments (CSG) Justice Center, launched a project in 2024 to assess the current landscape of crisis response services and Crisis Intervention Team (CIT) programs for people experiencing behavioral health issues who encounter the justice system. As a key component of the project, the CSG Justice Center facilitated several listening sessions to gather feedback and insights from state and county level leaders, behavioral health stakeholders, justice organizations, local practitioners, and subject matter experts with the goals of understanding the gaps within the state's current crisis infrastructure, assessing the implementation of CIT programming, and developing recommendations for enhancements, including sustainable funding mechanisms and better data collection and analysis.

This session will outline key findings and lessons learned from the information gleaned from the listening sessions and will feature a facilitated discussion with attendees to gather additional feedback and insights. Attendees will learn about successful practices and partnerships in CIT programming & crisis response in Pennsylvania; the most pressing needs for CIT and crisis infrastructure; and how state agencies and county leaders can best support successes, overcome barriers, and fill in service gaps.

Expanding the S.C.O.P.E. of Law Enforcement-Community Partnerships

Police spend a disproportionate amount of time addressing issues related to substance use, mental health, and poverty. Despite the long history of police working with social workers to address community problems, the shift toward coresponder programs, diversion and police-led deflection models have been slow to progress. The purpose of this session is to provide an overview of an innovative approach being used in Bucks County, Pennsylvania. The Sheriff's Community Outreach and Public Engagement - S.C.O.P.E. - initiative is designed to assist the citizens of Bucks County that may be experiencing a mental health crisis, need help with addiction, need assistance connecting to treatment, are experiencing homelessness, and may need assistance with handling court matters.

Attendees will hear how these counties have leveraged cross-system collaborations to sustain these programs and advance their efforts to better serve this population.

Trauma Informed Debriefs: What, Why and How?

Talking with trusted others about the disturbing things we've seen, heard, and experienced on the job can be a helpful way to process the traumatic aspects of our work. Unfortunately, the ad hoc, "gory story" sharing that often occurs in many workplaces spreads vicarious trauma, creating a "trauma contagion" effect that can negatively impact staff morale and productivity, and result in burnout, absenteeism, and turnover. This workshop will examine various purposes for informal debriefing conversations, key considerations for having these conversations in a trauma-informed way, and will teach a simple, readily implementable four-step process that anyone can use to have these important day-to-day conversations about the realities of the job in a way that protects both the speaker and the listener from unnecessary additional trauma exposure. (NOTE: This workshop will not cover formal debriefing strategies such as CISM/CISD or formal staff supervision debriefs.)
