Overview

Act 225 of 1982, as amended by Act 119 of 2008, charged the Pennsylvania Department of Agriculture with enforcing the commonwealth’s Dog Law.

The Bureau of Dog Law Enforcement (“BDLE”), under the Pennsylvania Department of Agriculture (“Department”), enforces all Dog Law-related regulations, including licensing individual dogs, licensing and inspecting kennels, humanely capturing dogs found running at large and placing them in shelters, investigating dangerous dog incidents, enforcing safety

measures for dogs deemed dangerous, investigating and prosecuting illegal kennel operations, and processing claims for livestock damage that dogs and coyotes cause.

Dog Licenses

County treasurers and agents sell dog licenses to Pennsylvania residents. For 2023, the cost of an annual dog license was \$6.50 for altered dogs, \$8.50 for unaltered dogs and \$31.50 for a lifetime license for altered dogs and \$51.50 for a lifetime license for unaltered dogs. In 2023, the legislature passed the Dog Law Modernization Bill, Act 18 of 2023, which raised fees for the first time in over 27 years. The increased dog license fees took effect on February 1, 2024. The cost of an annual dog license now is \$8.70, and \$52.70 for a lifetime license. There is no discount for altered dogs, since the licensure age is now at the point of transfer to a new owner (lowest is eight 8 weeks, which may be too young for an animal to be spayed or neutered). Revenue from the sale of annual and lifetime licenses is directed to the Dog Law Restricted Account. In accordance with the Dog Law, Philadelphia County and the cities of Altoona, Erie, Harrisburg, Pittsburgh, and Scranton administer their own dog license sales, retain all income and information generated, and do not report dog licensing sales income to the department (reference Appendix J for Section 1201 of the Dog Law, which addresses enforcement by independent political subdivisions).

There were 708,839 individual dog licenses sold in 2023, including 655,666 annual licenses and 53,173 lifetime licenses, generating \$4,914,304 in revenue (Appendix C).

The total number of dog licenses sold decreased by 3.7%, and the total license sales revenue decreased by 3.8% from license year 2022 to 2023. BDLE's current financial crisis and lack of adequate funding was directly related to poor license sales. With the passage of Act 18, BDLE expects to see improvement in the out years related to dog license sales and compliance due to increased dog licensing fees, education on dog licensing at point of transfer, and increased staffing.

Kennel Licenses

BDLE licensed 2,824 kennels in Pennsylvania in 2023, garnering \$534,450 in license fees directed to BDLE's restricted account (Appendix D).

Kennel license revenue decreased by 2.5% percent and the total number of kennels decreased slightly by .14% from calendar year 2022. Although the number of kennels (in-state) requiring inspection decreased slightly, with the passage of Act 18 BDLE expects this number to increase in 2024, as kennels seek to avoid advertising issues and new stiffer penalties for violators of the law.

Act 18 requires those advertising dogs for sale to include their kennel license number (if they are required to possess a license). This should reduce sales of dogs from unlicensed kennels and help the public make informed decisions. Additionally, kennels found operating without a license face increased civil and criminal penalties, such as \$1,000-\$5,000 civil penalties, and misdemeanor charges.

Out-of-State Dealers

In 2023, 125 out-of-state dealers were licensed generating \$12,900 in revenue for the restricted account (Appendix E).

Dog Law Inspections

A total of 5,929 kennel inspections were completed in 2023 (Appendix F). This is a slight increase of 0.08% over 2022.

Although a very slight increase in inspections occurred, BDLE still faced staffing hardships and primarily ensured that the statutorily required minimum of two inspections occurred. With the passage of Act 18, BDLE will be able to fill critical field vacancies for a stronger presence with regard to inspections; however, this will take time with expected improvement each year.

Enforcement Activities

BDLE refused or revoked two kennel licenses/applications in 2023; a decrease of 80% from calendar year 2022.

Forty-seven citations were issued for operating a kennel without a license in 2023; an increase of 21% from calendar year 2022.

In 2023, BDLE collected \$26,750 through administrative actions (settlements and civil penalties) and \$111,800 in Dangerous Dog registration fees.

Citation Issuance

In 2023, BDLE issued 2,790 summary citations and 275 misdemeanor complaints for kennel and other Dog Law violations including, but not limited to, failure to license, dogs running at large or abandoned, and dangerous dogs (Appendix H).

Since Fiscal Year 1998-99, 75% of the revenue from fines and penalties BDLE collected has been diverted to the Judicial Computer System Fund. Of the approximately \$275,000 collected in fines and penalties each fiscal year, only \$70,000 is retained in the Dog Law Fund.

In 2023, \$178,369, or 75% of the total fines and penalties BDLE collected was transferred out of the Dog Law Restricted Account and deposited into the Judicial Computer System Account. Since 1998, a total of \$5,427,055 has been transferred out of the Dog Law fund in accordance

with Act 64. This annual reduction of fines and penalties revenue is a contributing factor to the fund's solvency issues. Increasing revenue generated through fines and penalties collected has had no positive impact on the Dog Law Fund. At the end of 2023, the balance in the Judicial Computer System Fund was \$27,789,568 million, while the Dog Law Fund had a balance of only \$747,281 and is now requiring support from the department's General Fund. Filing more citations will not resolve BDLE's insolvency.

Dogs Seized and Impounded and Total Reimbursements

BDLE plays a critical role in managing stray dogs by assisting with the humane capture and transport of dogs to shelters. Shelters and municipalities receive payments to help cover the costs associated with transporting, feeding, and caring for stray dogs. BDLE paid \$8,795,905 for 1,781 dogs statewide (Appendix I). Since January 1, 2021, the reimbursement rate per dog has been the minimum of \$5 required by regulation. This is due to BDLE's insufficient funds.

Dog Law Restricted Account – Revenue and Expenditures for Calendar Year 2023

A restricted account funds all BDLE activities. All revenue and expenses related to BDLE are credited and disbursed from the Dog Law Restricted Account as required by Section 1001 of the Dog Law.

To prevent the Dog Law Restricted Fund from going negative in 2023, \$2,500,000 in Administrative Overhead expenses were transferred out and charged to the department's GGO waiver funding.

Licensing Fees

The primary source of revenue for the Dog Law Restricted Account is the sale of individual dog licenses. This is supplemented by kennel licenses and fines that are capped at approximately \$70,000 annually. Individual dog license sales generated approximately \$4.9 million in 2023.

A Brighter Future



Thanks to Governor Shapiro, Senator Vogel and our partners in the General Assembly, Governor Shapiro signed Senate Bill 746 into law on October 23, 2023 becoming Act 18 of 2023.

Act 18 will improve public safety and animal welfare standards, enhance transparency and customer service, and modernize the licensing process for dog owners, while providing financial stability for BDLE. Act 18 took effect on January 21, 2024.

Improved Public Safety and Animal Welfare Protections

Improved Public Safety and Animal Welfare Protections



- **Improved funding**
- **Protections from dangerous dogs**
- **Stiffer penalties**
- **Ensures appropriate kennel licensing**
- **Proactive steps for disease control and prevention**

- **Resolving insolvency**
 - Individual dog license fees increased for the first time in 27 years; all annual dog licenses cost \$8.70 while all lifetime dog licenses cost \$52.70 with discounts for persons over 65 and persons with disabilities.
 - Kennel license fees have increased for the first time in nearly 60 years; increasing by approximately 25%.
 - Increasing license fees allows BDLE to hire additional dog wardens for understaffed regions and ensures that the public will be better served. This also allows for increased kennel inspections and kennel complaint investigations.
- **Keeping communities safer**
 - Requires dogs under quarantine for a human exposure dog bite to be muzzled, leashed and under the physical restraint of a responsible person.
 - Makes it easier for law enforcement to make a dangerous dog determination and simplifies the filing and prosecution of dangerous dog charges.
 - Puts financial responsibility on the dog owner in situations in which a dog is to be seized and held pending an appeal rather than being left in the community.
- **Stiffer penalties**
 - The criminal penalty range for summary violations has increased from \$100 – \$500 to \$500 – \$1,000. The misdemeanor criminal penalty range increased from \$500 – \$1,000 to \$1,000 – \$5,000 in effort to make it less appealing to violate the Dog Law provisions.
 - The penalty for operating a kennel without a license has increased from a first-time summary offense to a misdemeanor of the third degree. The civil penalty amount also increased with a fine range of \$1,000 – \$5,000 for each day it operates in violation of the act.

- **Increased protections for kennel dogs**

- Allows the department to revoke a kennel's license or refuse a kennel license application from individuals convicted of animal cruelty.
- Requires kennels to obtain the appropriate type and class of kennel license for their operation based on how they conduct business.
- Provides isolation requirements after a dog is imported as a proactive step in disease control and prevention, providing increased protection from disease for dogs, and preventing consumers from bringing sick dogs into their homes.
- Requires that enclosures for dogs do not allow them to extend limbs into other enclosures, thus adding further protections from injury.

Enhanced Transparency



- **Consumer Protections**

- Requires those selling or adopting dogs directly to the public to post the dog's identifying information; the location of the breeder; state or federal license number; documentation of all vaccinations; and any known bite history.
- The additional informational allows potential customers to make informed decisions in the best interests of their family.

- **Weeding out bad actors**

- Requires those advertising dogs for sale or adoption to include their federal, state, or local license number to any advertisement offering dogs for sale.
- This will allow BDLE to quickly determine whether a kennel is operating illegally, cuts off resources for bad actors, and allows potential customers to look up PA kennel licenses to view inspection history.

Modernization

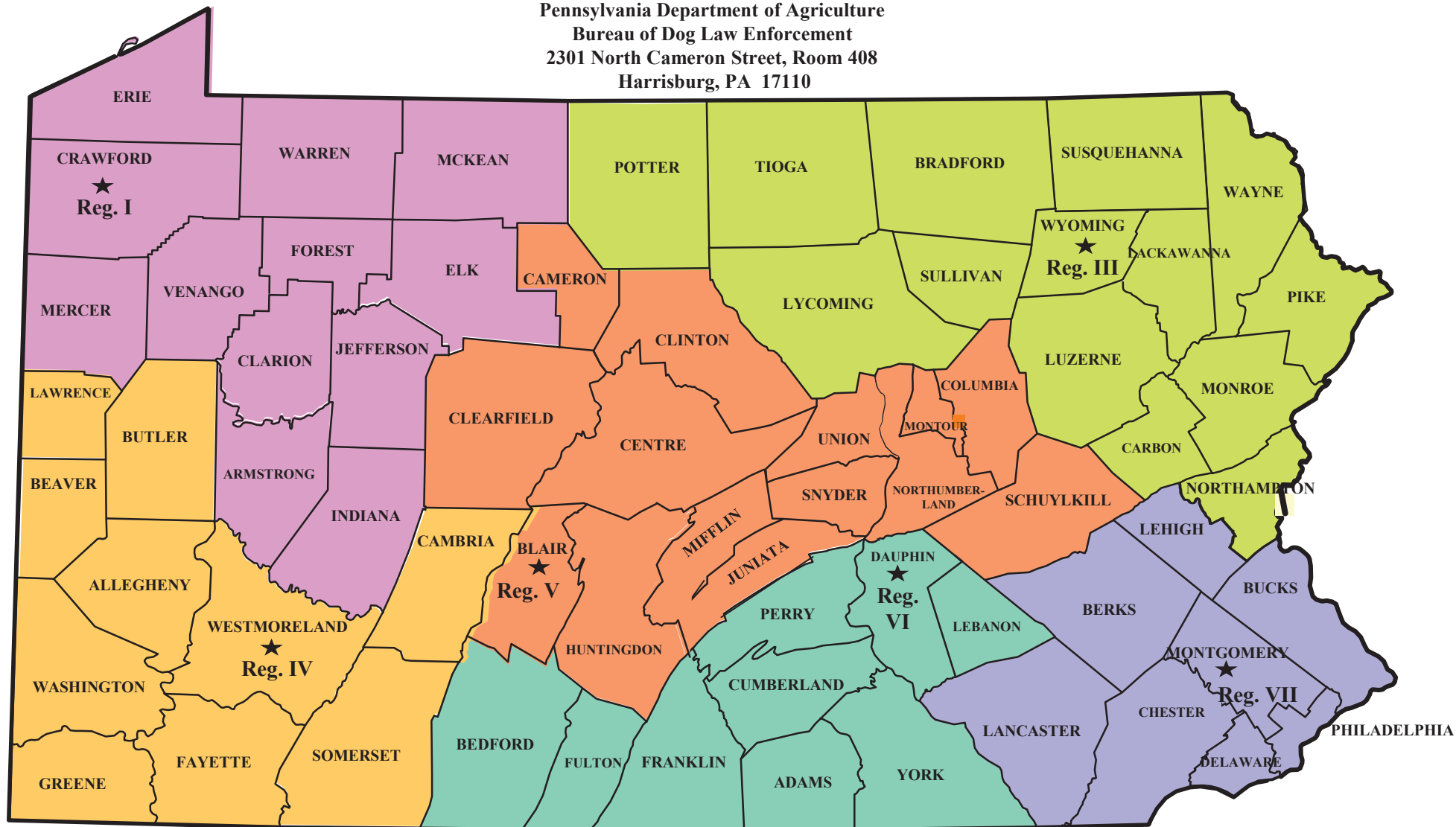


- **Dog Licensing Compliance**
 - Closes the gap between when a dog is transferred to a new owner and when it must be licensed. This allows dog owners to apply for a dog license at the time of transfer rather than waiting (8 weeks is earliest a dog can be transferred to a new owner).
 - This will greatly increase dog licensing numbers by providing education about dog licensing at time of purchase or adoption.
- **Dog licensing**
 - Sellers and adopters of dogs will be required to provide new owners with a copy of the dog license application along with a brochure regarding dog licensing and the benefits it provides.
 - Allows for dog owners in all counties to purchase dog licenses online, which will also greatly improve licensing compliance statewide by adding convenience for customers.

Implementation

BDLE is committed in taking an educational approach to the implementation and enforcement of Act 18. BDLE recognizes that there are provisions that are very new for stakeholders as well as itself and will be working directly with stakeholders to help them be compliant with the new provisions of Act 18.

Appendix J – Section 1201 of the Dog Law
Addressing Enforcement by Independent Political Subdivisions

ARTICLE XII

MISCELLANEOUS PROVISIONS

Section 1201. Applicability to cities of the first class, second class, second class A and third class.

(a) Cities of the first class, second class and second class

A.— Insofar as this act provides for the individual licensing of dogs and the payment of damages for domestic animals injured by dogs or for licensed dogs illegally killed, it shall not apply to cities of the first class, second class and second class A. Such individual dog licensing and payment of damages in cities of the first class, second class and second class A shall continue to be carried on under the provisions of existing laws.

(b) Cities of the third class — Insofar as this act provides for the individual licensing of dogs by the department, the payment of damages by the department for domestic animals injured by dogs or for licensed dogs illegally killed and for the performance of duties and functions of dog law enforcement by the department under Articles I and II, except sections 206, 207, 209, 211 and 218 as it pertains to kennel inspections; Article III, except section 301; Articles V through IX; this article; Articles XI and XII, the foregoing responsibilities shall not apply to the department within a city of the third class that does both of the following:

(1) Adopts its own dog licensing ordinance establishing individual dog licensure on a calendar year basis or on another basis consistent with that in use by the department.

(2) Notifies the secretary, in writing, of its intention to assume responsibility for enforcement of its dog licensing ordinance under authority of this section for a period commencing January 1 of a particular year, and not ending prior to December 31 of the year in which the city of the third class terminates its responsibility for enforcement. If the department changes dog licensure from calendar year basis to some other basis by regulation promulgated under authority of section 201, it may modify the requirement set forth in this paragraph to provide for the efficient and equitable transfer of dog law enforcement responsibility and appropriate dog license fees from the city of the third class to the department.
