# **GRANT PROGRAMS & CHANGES**

#### **Federal Funds**

- SBG
  - No program changes
- BIL
  - PennDOT BOA to provide an additional 5% share to cover the local portion for a total of 10% in state match to the Block Grant airports for grants issued after July 1, 2024.
- AIP Match
  - CAP remains at \$600k per year per airport
  - Includes AIP and AIG overall total
- CPF or other Federal programs
  - No State match will be provided



# **GRANT PROGRAMS & CHANGES**

#### **State/Local Grant Changes**

- All airfield pavement rehabilitation, maintenance equipment, fuel farms, maintenance materials will now be 90/10 eligible
- July 1<sup>st</sup> Invitation to Apply will go out for the entire year. You will have the entire year to get the project under grant.
- We will hold off on issuing grants if no RFR's submitted in previous 12 months
  - Spend the funds or will give grant to another airport
  - Helps maximize grant dollars by minimizing the impacts of inflation
  - System sustainability to the overall system

# PLANNING SESSIONS

#### 2024 Dates May - June

#### **New Requirements**

- Sponsor supplied annotated FYP <u>prior</u> to planning session
- No changes to years 1-3 after this year's planning session

#### **JACIP Changes**

- Projects page will show projects within years 1-5
- Projects in years 6-12 can be tracked on a spreadsheet or pdf provided by the Sponsor during their annual planning session



# **eGRANTS – CAPITAL BUDGET**

#### eGrants will be utilized for Capital Budget requests in 2024

- Sponsor begins application in eGrants after announcement in fall 2024, as their Capital Budget request.
- BOA staff will review, rank, and recommend projects
- If approved, BOA will advance the application and the project will be under grant.
- JACIP is removed from the process

This will help get projects moving and approve projects that are ready to start.

Helps maximize grant dollars by minimizing the impacts of inflation



#### **DISADVANTAGED BUSINESS ENTERPRISE (DBE)**

#### Disadvantaged Business Enterprise (DBE)

- SBG MOA (10/25/23) with FAA
- BOA delegating DBE program responsibilities to the sponsors
- Level of oversight will be required by PennDOT
- BOA is working BEO to develop a training webinar for our Block Grant Sponsors (summer 2024)
