














Local Transportation Funding PennDOT Allocated Funds

The table below provides a quick overview of commonly-requested items and activities for local roads and transportation systems, including various direct allocation to municipalities that may fund them. Note: this tool provides general guidance on the programs listed below, project eligibility for all items should be confirmed by visiting the referenced websites and speaking with your Municipal Services Representative or Financial Consultant.

Descriptions of Consolidated Rows:

Road Maintenance and Repairs: Includes paving, resurfacing, patching, sealing, and general repairs across county and municipal roads.

Bridge Maintenance and Repairs: Consolidates all bridge-related repairs, rehabilitation, and preservation activities, including those specific to municipal jurisdictions.

Traffic and Safety Management: Combines traffic signal maintenance, pavement markings, signage, traffic calming measures, and accessible ramps.

Vegetation and Environmental Management: Encompasses mowing, tree trimming, environmental mitigation, and other similar vegetation management activities.

Project Planning and Administrative Costs: Groups costs related to the planning, design, engineering, and administrative oversight of projects.

Public Transit and Accessibility Improvements: Includes enhancements at transit stops and accessibility improvements, funded by specific grant programs.

Bridge Specific Projects: Dedicated to specific bridge projects funded by certain programs, including replacements and structural enhancements.

Emergency and Safety Projects: Addresses emergency repairs, immediate safety hazards, and disaster responses.

Multimodal and Infrastructure Enhancements: Supports projects that enhance multimodal transportation and infrastructure improvements.

Routine and Preventive Maintenance: Covers routine inspections, minor repairs, and preventive maintenance practices for roads and bridges.

Specific Public Safety Initiatives: Focuses on funding public safety related to road and traffic safety.

* Only for Counties that have enacted the \$5 Fee for Local Use

** Only for municipalities/counties that have turnback roads through an agreement with PennDOT

*** Administrative costs are limited to 10% of total allocation, some planning costs eligible
