1) ADMINISTRATIVE ITEMS

- a) All contractors, subcontractors and consultants of the Buyer must be pre-approved by the Commission. The Commission reserves the right to reject any subcontractor at its sole discretion. If the Contractor enters into any subcontract(s) not previously approved by the Commission, the Commission shall have the right to require the Contractor to terminate such contracts.
- b) This 86.4 sale area contains 4 harvest blocks.
- c) 3 blocks are contained within deer fences caution must be taken to avoid damaging these fences. Any damage that occurs must be repaired immediately at the buyer's expense.

4) ROADS TO BUILD / IMPROVE

a) Roads to Maintain

- 1. All haul roads used by operator will be suitably drained and crowned (2% 6% slope) with a road grader or dozer with a 6-way blade at conclusion of sale or if the roads are in poor condition and the sale is going to be left idle for any length of time.
- 2. A stone rake and 10-ton vibrating roller will also be required following grading operations. All road edges including berms will be graded to a contour that allows for the sheet flow of water from the driving surface to an area where it can infiltrate naturally or a ditch if necessary, as determined by the regional forester.
 - a. State game lands roads = 13,311 feet
- 3. A 750-foot section will receive additional subbase at 12 inches deep and 15 feet wide. This will equate to 625 tons of subbase to be haul in from off site.

5) LANDINGS

- a) Four landing locations 100 foot by 100 foot are designated on the sale map.

- c) All bark, logging debris, and cull portions of the trees will be removed from the landings at conclusion of use, or any time specified by the regional forester.

6) **SKIDDING**

- a) No skidding will be allowed through streams, islands or across unprotected pipelines or spring seeps.

- c) Skidders are to be kept off haul roads as much as possible.

- e) If skid trails are to sit idle for one month or more, they are to have water bars added.

- g) Main skid trails are to be leveled, open and have water bars added at the conclusion of the sale.

7) SEEDING OF ROADWAYS AND LANDINGS

a) At conclusion of sale all areas to be seeded will be properly graded with a grader or a dozer with a six-way blade and stone raked to clear all rocks 4" and larger. Seeding will include landings, and major skid trails as determined by the regional forester. All seeding will be according to the following:

8) OPERATIONS AND NON-WORK DAYS

 - 2. The opening day and all Saturdays during spring turkey season, including the youth spring gobbler hunt.
 - 3. All the days of the general statewide bear season
 - 4. The entire 2 weeks of the general firearms deer season
 - 5. The opening day of the flintlock muzzleloader season

No woods operation will be permitted from **March**, **1**st **thru April**, **15th** without the permission of the forester-in-charge.

- b) The contractor, employees, and sub-contractors may not hunt to, from, or at the job site when the work location is beyond a gated road that is closed to public traffic. The contractor may travel to and from the work location on no-work days to check on the condition of equipment.
- c) The contractor is responsible for the control and collection of fluids leaking from any equipment used on the site. The contractor must have a spill containment and cleanup kit appropriate for the equipment being used. At a minimum, the kit will contain: plugs and clamps to control hydraulic line breaks, a container to collect leaking fluids, fluid absorbent pads and a shovel. Operating any equipment noticeably leaking fluids is prohibited. The contractor must collect, and control fluids leaking from any equipment and dispose of properly.
- d) It is unlawful to be present on State Game Lands from November 15 through December 15 inclusive when not engaged in lawful hunting or trapping and fail to wear a minimum of 250 square inches of daylight fluorescent-orange material on the head, chest, and back combined, or in lieu thereof, a hat of the same-colored material. The material shall be worn so it is visible in a 360-degree arc.
- e) The Buyer, his employees and sub-contractors are expected to perform all logging operations in a safe manner as required by applicable laws and regulations. - a) The Pennsylvania Right-to-Know Law, 65 P.S. §§ 67.101-3104, applies to this contract.
- b) Unless the Contractor provides the Commonwealth, in writing, with the name and contact information of another person, the agency shall notify the Contractor using the Contractor information provided by the Contractor in SRM [or "the legal contact information provided in this contract"] if the agency needs the Contractor's assistance in any matter arising out of the Right to Know Law ("RTKL"). The Contractor shall notify the agency in writing of any change in the name or the contact information within a reasonable time prior to the change.
- c) Upon notification from the Commonwealth that the Commonwealth requires the Contractor's assistance in responding to a RTKL request for records in the Contractor's possession, the Contractor shall provide the Commonwealth, within fourteen (14) calendar days after receipt of such notification, access to, and copies of, any document or information in the Contractor's possession which arises out of the contract that the Commonwealth requests ("Requested Information") and provided such other assistance as the Commonwealth may request in order to comply with the RTKL. 
