### **Position Details:**

Title: Engineering, Scientific & Technical Intern (**6 positions**)

- \$17.00/hour, 40 hours/week
- Monday-Friday, 7:00 a.m. – 3:30 p.m. with possibility of working Monday-Thursday 6:30 a.m. to 5:30 p.m. for certain locations.
- Maximum of 749 hours per calendar year
- Anticipated start date: May 12, 2025\*
- Anticipated end date: August 22, 2025\*

### **Description of Work:**

Interns will assist Southcentral Region Habitat Management staff with the development, implementation, coordination and evaluation of habitat management activities on State Gamelands (SGL) within the Region. The Southcentral Region consists of Adams, Bedford, Blair, Cumberland, Franklin, Fulton, Huntingdon, Juniata, Mifflin, Perry, Snyder and York Counties.

Duties may include, but are not limited to, planning / implementing basic habitat management projects, operating machinery and hand tools, mowing. Infrastructure projects such as road work and bridge construction, gate maintenance and other infrastructure related duties, collecting SGL data to input into our GIS database, spraying / controlling invasive plant species and assisting with prescribed fire programs. Interns will work with other staff, such as Forestry and Biology, to learn more about the Game Commission and what we do. This is hands on and manual labor-oriented internship.

### **Job Requirements & Qualifications:**

- Work will be outdoors and involve traversing uneven terrain in all weather conditions
- Valid driver's license.
- Preferred candidates will have college level coursework or experience in the field of wildlife, forestry or natural resource management.
- Must be enrolled full time ( $\geq 12$  credits in a bachelor's or associate degree in a science, technical or engineering program such as wildlife/fisheries science, biology, natural resource management, ecology, forestry, botany or related field.
- A graduating high school student who is 18 and enrolled in college for the fall semester is eligible.
- Must be returning to a college or university, full time ( $\geq 12$  credits), in the fall of 2025.
- Self-motivated and able to follow verbal and written instructions.
- Good interpersonal skills and works well in a team environment.
- Communicate effectively orally and in writing and interact with PGC staff and the public in a professional manner.
