TAKE AIM AT SPRING GOBBLER SEASON

There's something special about the first light of dawn breaking over Penn's Woods. Spring gobbler season is just around the corner!

Spring gobbler season runs statewide from May 3-31, 2025. A special youth hunt takes place on April 26, 2025, for licensed junior hunters and permitted mentored youth.

Turkey hunters can harvest up to two bearded birds, one per day (second spring gobbler may be only taken with a valid special wild turkey license). Hunting hours vary.

LET WILDLIFE BE WILD

Springtime brings newborn wildlife like rabbit kits, nestling songbirds, and deer fawns. If you spot young wildlife, don't disturb them. Many wildlife parents leave their young alone and hidden to avoid attracting predators and will return only a few times a day to nurse. You can also help wildlife be wild by not feeding them and viewing them from a safe distance.





PLANT NATIVE PLANTS

Planting native trees, shrubs, and flowers provides food and cover for a variety of wildlife species. Native plants support birds, bats, bees, butterflies, and small mammals, which play an important role in sustaining healthy ecosystems. In contrast, non-native or invasive plants can have harmful effects on ecosystems by outcompeting native plants and don't provide nearly as many benefits to wildlife.

NEW STATE GAME WARDENS ADDED TO RANKS

The Pennsylvania Game Commission proudly welcomed 18 new state game wardens to its force when the Ross Leffler School of Conservation graduated its 36th class on Feb. 1, 2025.

These new wardens went through 44 weeks of rigorous training, including game law enforcement principles and methods, public relations, wildlife forensics, conducting wildlife surveys, and hunter education instruction.

They're now working in their assigned districts to help the Game Commission fulfill its mission to manage and protect wildlife and their habitats while promoting hunting and trapping for current and future generations.

PRELIMINARY 2025-26 HUNTING & TRAPPING SEASONS

The Pennsylvania Board of Game Commissioners gave preliminary approval to the 2025-26 hunting and trapping seasons and bag limits during its January meeting at the agency's headquarters in Harrisburg.

The public can offer comments on board actions before the April meeting, when 2025-26 seasons and bag limits will be finalized and antierless license allocations will be presented. Visit <u>pa.gov/pgc</u> to review the preliminary seasons and bag limits and share your comments with the board.

PRESCRIBED FIRE FOR WILDLIFE HABITAT

The Game Commission conducts prescribed fires, or prescribed burns, at the right place, at the right time, and at the right intensity to restore wildlife habitats. These fires remove invasive plants and dead plant matter to promote healthy new growth.

They benefit wildlife in the long term and have little negative impact on wildlife in the short term. In fact, wildlife are attracted to burned areas immediately after the fire to forage on the flush of insect activity and fresh vegetation.

Throughout the spring, highly trained crews will be conducting prescribed fires across select state game lands. Visit <u>pa.gov/pgc</u> to learn more about prescribed fire, view the map of upcoming burns, and sign up for prescribed fire notifications in your county.



EXPLORE STATE GAME LANDS

The first state game lands turns 105 years old in 2025!

The state game lands system began with State Game Lands 25 in Elk County on June 25, 1920. Today, there are over 1.5 million acres of state game lands in 66 of 67 counties, providing critical habitat for wildlife and recreation opportunities for hunters, trappers, and wildlife enthusiasts.

In addition to quality habitat, 66 public shooting ranges on 40 separate game lands across the state provide recreational opportunities to millions of shooters in Pennsylvania.

- Some early game refuges purchased later as state game lands kept their refuge numbers, including State Game Lands 12, 13, 14, and 24.
- State Game Land 93 was originally located in Clearfield County. The designation was transferred in 2006 to a 724acre tract purchased adjacent to the Flight 93 National Memorial in Somerset County.

 - 1. SGL 13: 50,742.14 acres (Sullivan and Columbia counties)
 - 2. SGL 57: 45,985.09 acres (Wyoming and Luzerne counties)

Pennsylvania's elk application period is open through Sunday, July 13, 2025.

Apply for 11.97 per season or \$35.91 for all three (archery, general, and late firearms) online at huntfish.pa.gov or at a licensing issuing agent.

The license reveal will be held at the Keystone Elk Country Alliance Elk Expo in Benezette on July 26, 2025.
