CONSENT ORDER

AND NOW, July 16, 1962, pursuant to Section 105.17 of the Regulations of the Pennsylvania Human Relations Commission, the above case having been scheduled for public hearing, the respondents having waived the public hearing and all parties having agreed that a Consent Order may be entered without holding any public hearing or making any findings of fact or conclusions of law, it is hereby

ORDERED, by the Pennsylvania Human Relations Commission (by Hearing Commissioners, Harry Boyer, presiding member, Jesse D. Reber and Edward G. Petrillo, Esq.) :

1. That the respondents, Henry F. Smith and Linda Smith, his wife, individually and doing business as Red Run Lodge, shall not maintain a policy of barring Negroes, because of their race or color, from being admitted to the Red Run Lodge so long as the respondents operate the said Lodge as a

place of public accommodations by keeping it open to, accepting or soliciting the patronage of the general public.

2. That the respondents, Henry F. Smith and Linda Smith, his wife, individually and doing business as Red Run Lodge, shall take the following affirmative action which, in the judgment of the Commission will effectuate the purposes of the Pennsylvania Human Relations Act :

(a) Advise and direct in writing all of the respondents' managers, agents and employes having any duty or function with respect to the registration, admission or supervision of individuals seeking admission to Red Run Lodge, either for lodging or for food, that it is the policy and intent of the respondents to comply fully with the Pennsylvania Human Relations Act and that at any and all times when the respondents keep their Lodge open to the general public, they will not refuse to admit individuals, either for lodging or for food, because of their race, color, religious creed, ancestry or national origin;

(b) Furnish the Commission with copies of said directive signed by each recipient to indicate its receipt by each of them;

(c) Post and maintain in conspicuous places where individuals seeking admission to Red Run Lodge either for lodging or for food may see them, copies of the Commission's poster, furnished by the Commission; and

(d) Notify the Pennsylvania Human Relations Commission at its office at No. 1101 Labor and Industry Building, Harrisburg, Pennsylvania, in writing within thirty (30) days from the date of this Consent Order as to respondents' compliance with this Order.
