LICENSE NON-RENEWAL NOTIFICATION AND ENFORCEMENT

Dealer, Subdealer, and Hauler license renewals are due by June 15 each year. The license year begins July 1.

It is a violation of the Milk Marketing Law to operate as a dealer, subdealer, or hauler without a license. It is also a violation of the Milk Marketing Law for licensees to do business with unlicensed dealers, subdealers, and haulers.

Below is a list of unlicensed dealers, subdealers and haulers as of July 1, 2024. Effective July 15, 2024, Staff will begin making legal referrals for licensees who continue to do business with these unlicensed entities. Staff will also institute legal proceedings directly against unlicensed entities as necessary.

The Board publishes lists of active licenses on its website. Those lists will be updated as licenses are issued. The lists can be found on the respective license pages.
