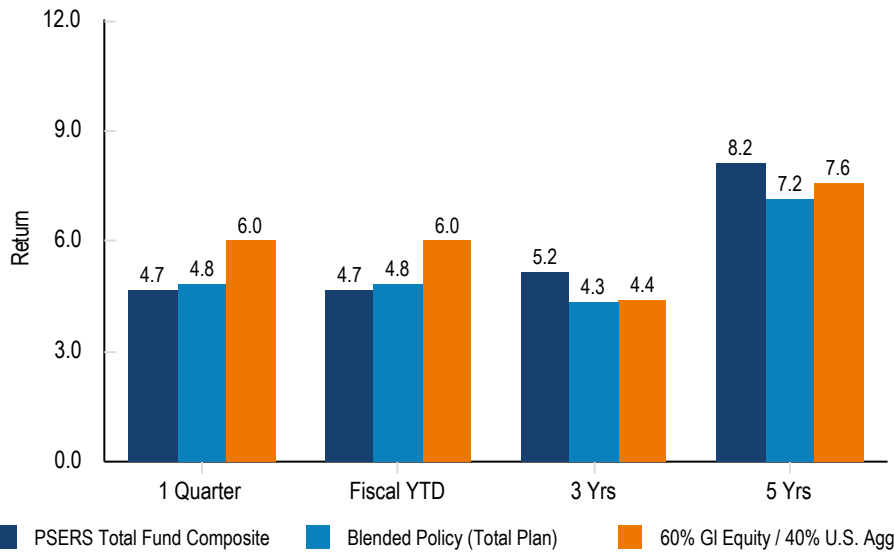

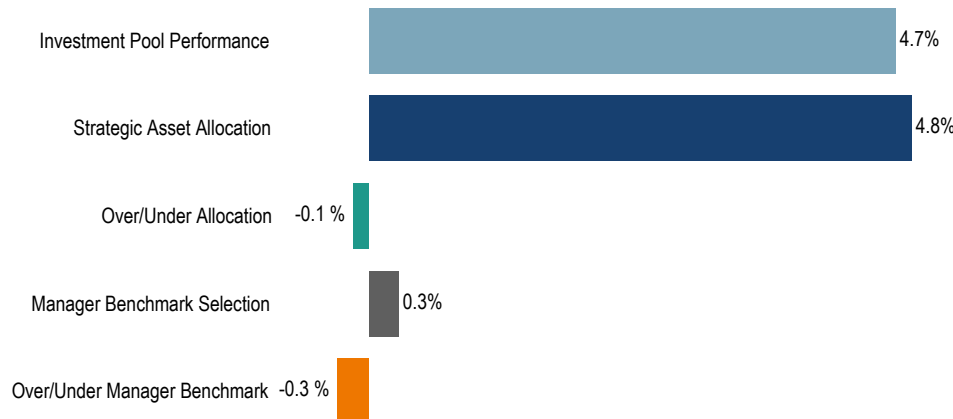

Fiscal Year to Date Performance Attribution



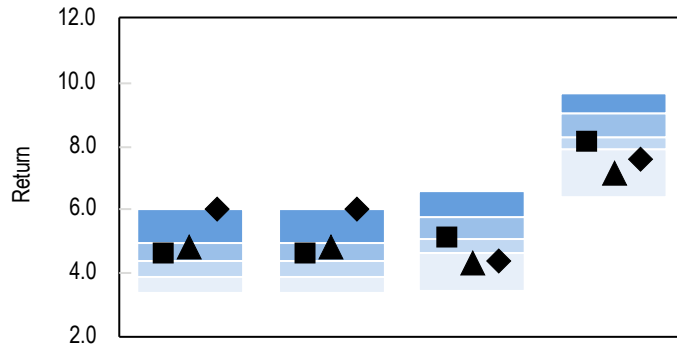
Fiscal Year to Date Performance Commentary Relative to Policy

In the third quarter, PSERS total fund returned 4.66% and underperformed its blended policy benchmark return of 4.82% by 16 basis points.

Manager underperformance detracted -0.29% from the total fund return, primarily due to manager performance within non-U.S. equities (-0.14%), public infrastructure (-0.10%), and private equity (-0.08%).

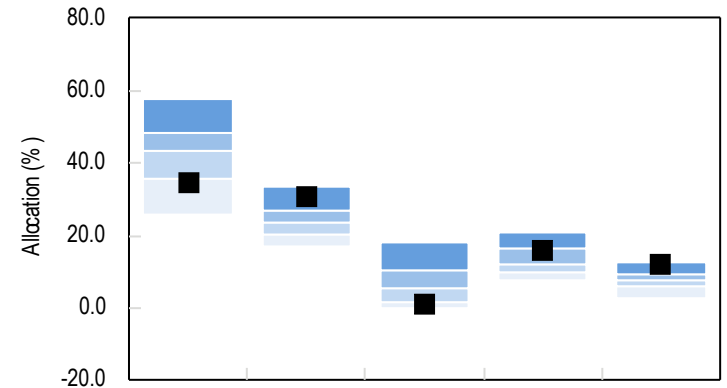
Asset allocation differences from policy detracted modestly (-0.13%) from performance, with an underweight to investment grade fixed income being the largest detractor (-0.20%). A slight overweight to non-U.S. equities was the largest contributor (+0.16%) to allocation differences.

Performance vs. InvMetrics Public DB > \$5Bn



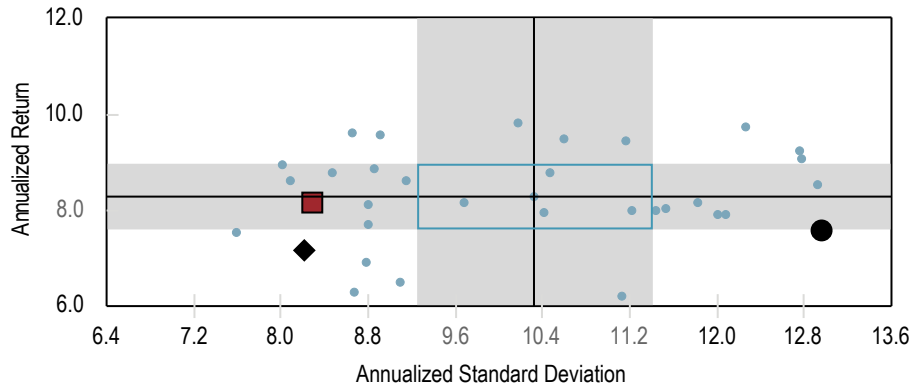

Fiscal Year to Date Performance Commentary Relative to Peers

PSERS began the new fiscal year ranked above median in their peer universe (37th percentile) for the quarter. The median peer returned 4.38% compared to PSERS return of 4.66%. The global 60/40 portfolio returned 6.05% and ranked in the top 6% of the peer group because the private markets asset classes held in most peer portfolios underperformed the public equity market.

Long duration positioning was beneficial relative to peers as PSERS U.S. long treasuries returned 7.83% and were the best performer within fixed income. Most peer fixed income portfolios are more in line with the market-duration Bloomberg U.S. Treasury Index, which returned 4.74%.

PSERS allocation to public infrastructure also helped relative to peers as PSERS maintains a higher allocation than the average peer. Public infrastructure returned 12.23% and was one of the top performing asset classes in the portfolio.

In the plan peer allocations, total equity includes public infrastructure, but does not include private equity. Total fixed includes private credit. Total real estate includes private infrastructure.

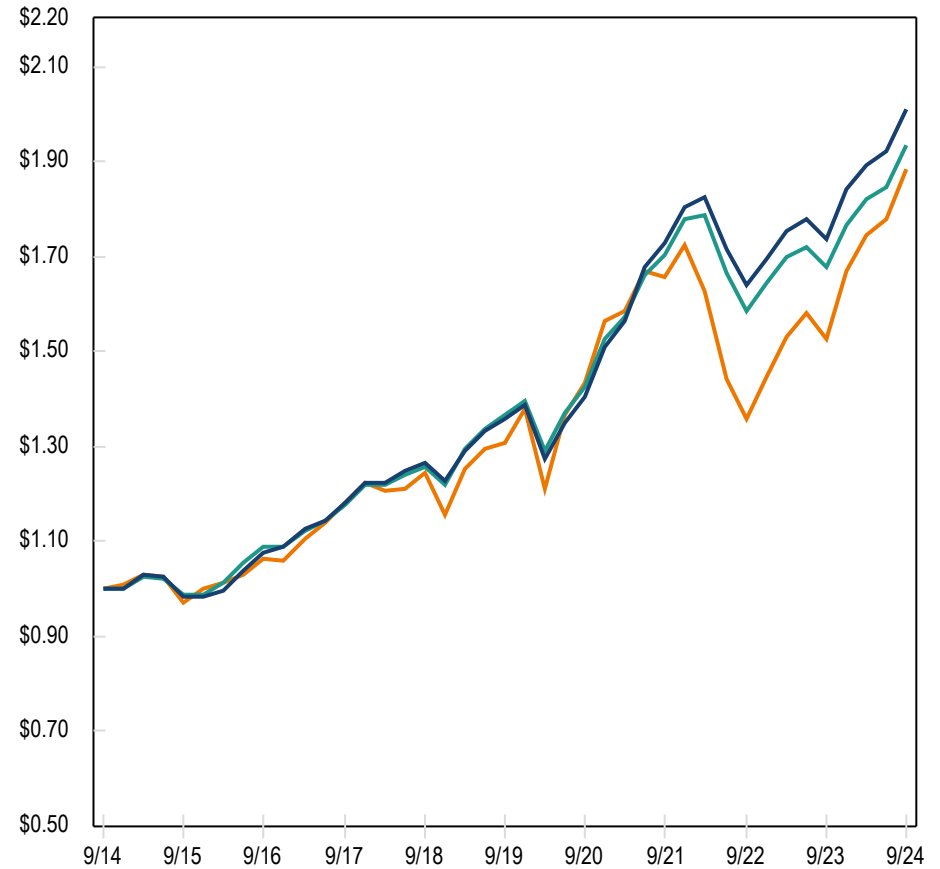

Total Fund Cumulative Performance vs. InvMetrics Public DB > \$5Bn

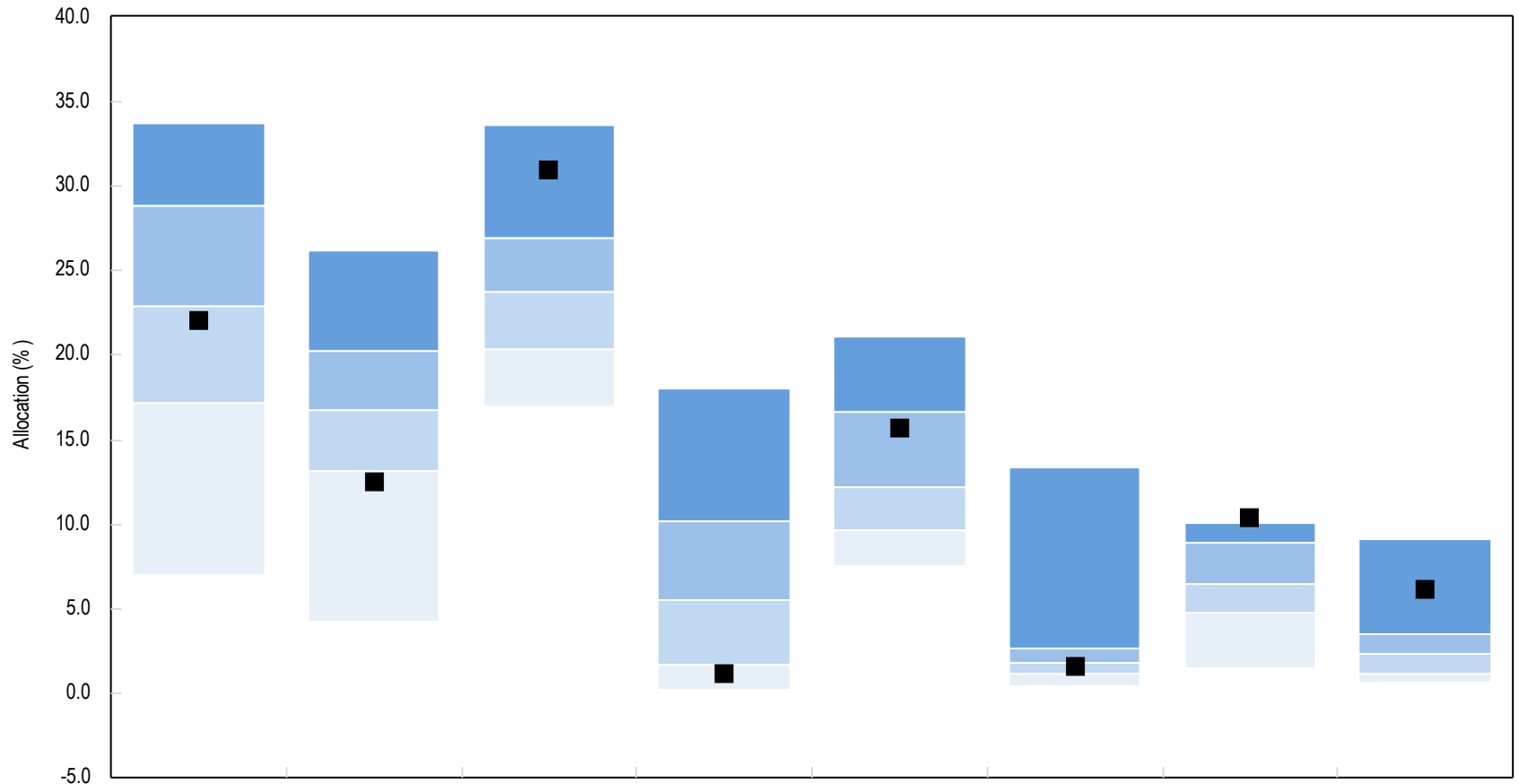

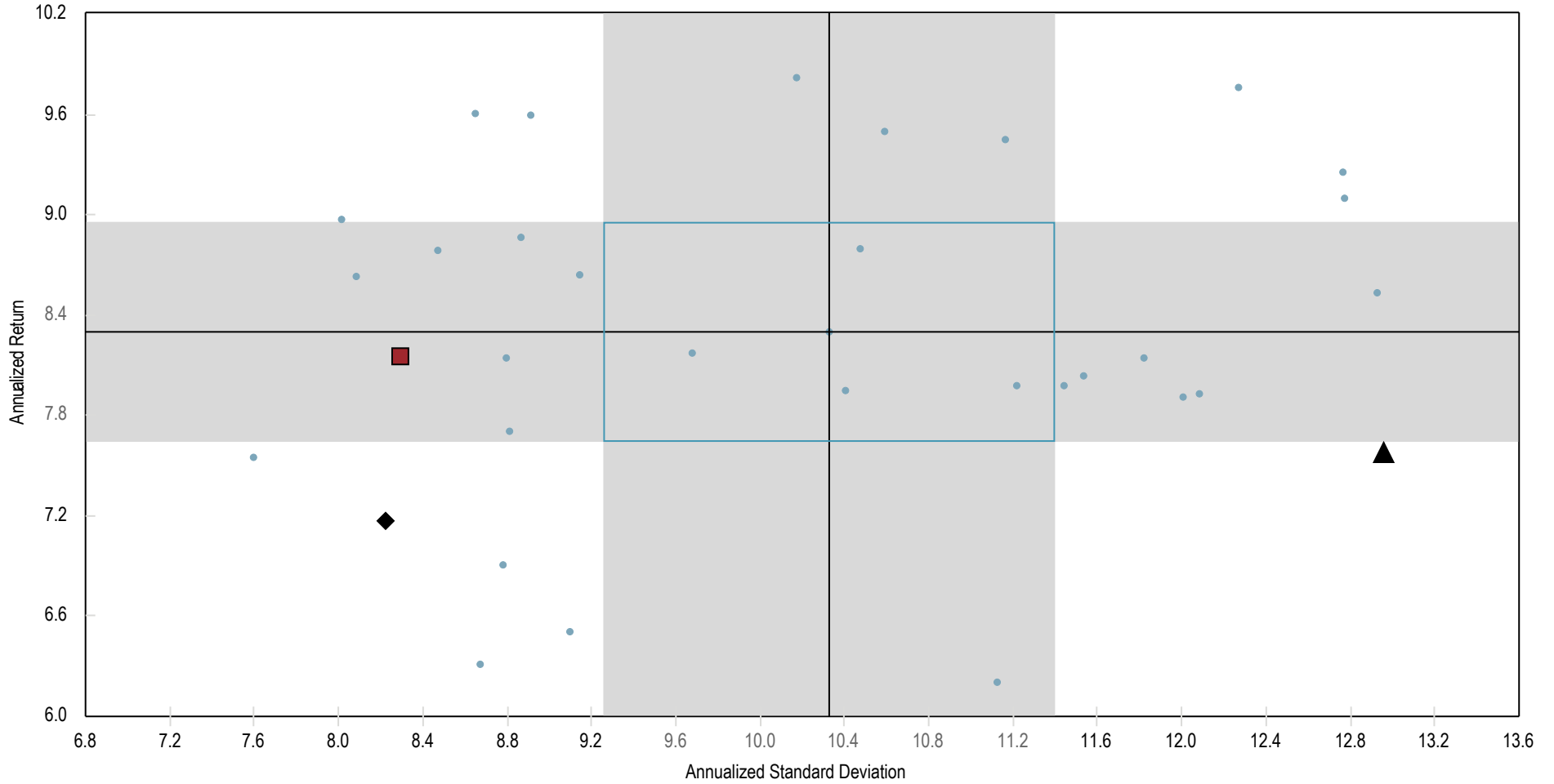
Total Plan Allocation vs. InvMetrics Public DB > \$5Bn

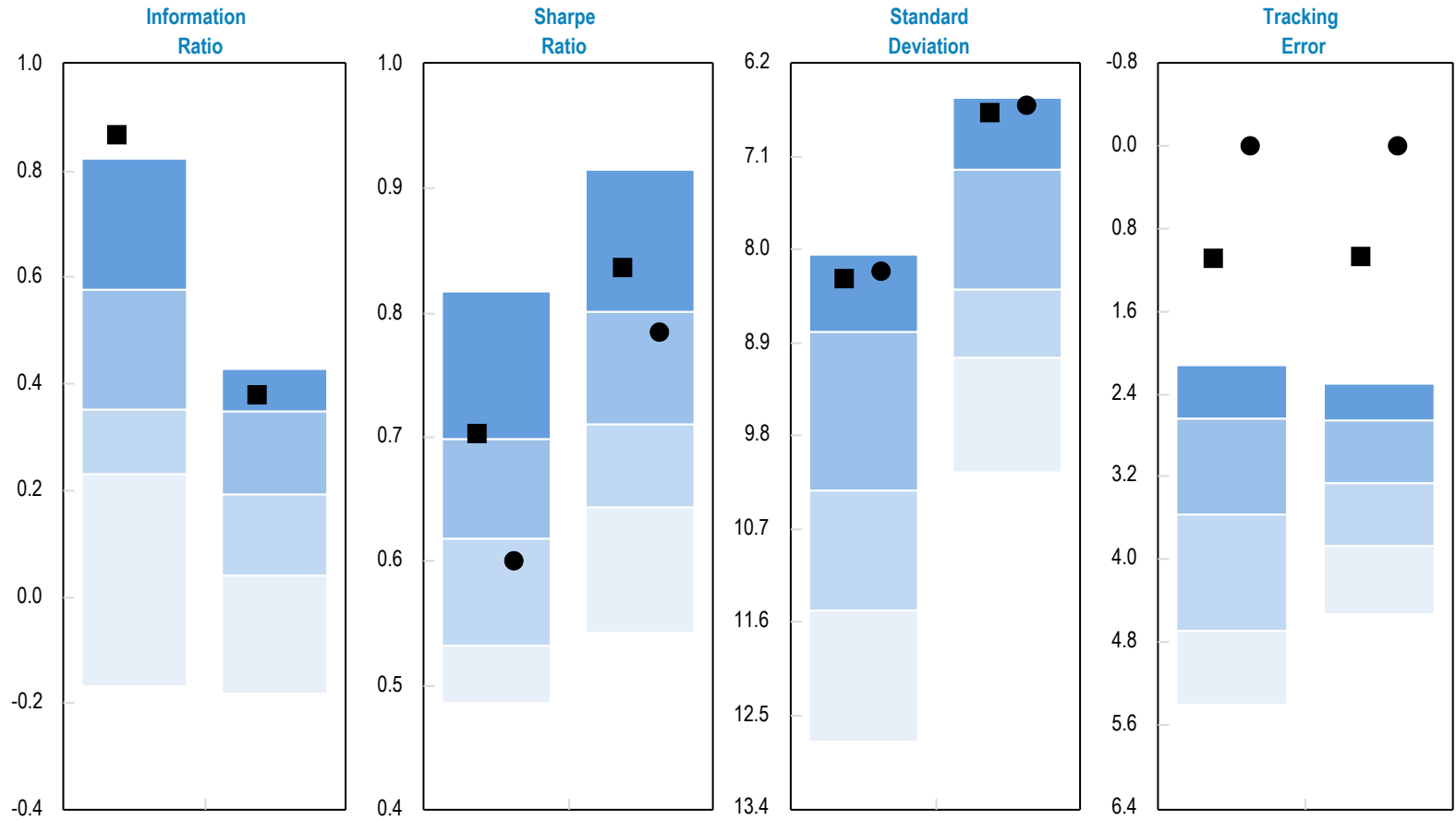
5 Years Annualized Return vs. Annualized Standard Deviation
