MINUTES STATE BOARD OF HIGHER EDUCATION Microsoft Teams Meeting September 26, 2024

I. CALL TO ORDER

VI. REVIEW PENNSYLVANIA POSTSECONDARY CONTEXT, STATE BOARD OF HIGHER EDUCATION AUTHORITY AND REQUIREMENTS

Dr. Kate Shaw, Deputy Secretary and Commissioner for Higher Education, introduced the current state of the higher education landscape in Pennsylvania and provided an overview of the Board's enabling legislation and statutory duties.

VII. ESTABLISHMENT OF PERFORMANCE-BASED FUNDING COUNCIL AND COMMITTEES

Dr. Shapira raised the following priorities as required under the legislation or aligned to work required by law, with the caveat that other councils, committees, or task forces may be formed as the need arises:

- Establish a Performance-based Funding Council.
- Establish the following committees: Bylaws, Transition of Authority, Strategic Planning, and Statewide Postsecondary Data
