### APPROVAL OF MINUTES

The minutes of the May 8, 2019, meeting of the Council of Basic Education were approved on a **Hallett/Lally-Green** motion.

## REPORT OF THE DEPUTY SECRETARY FOR ELEMENTARY AND SECONDARY EDUCATION

Deputy Secretary Matthew Stem recounted that at the Council's last meeting on May 8, 2019, he presented background on changes to high school graduation requirements in Pennsylvania enacted by Act 158. He remined the Council that the Act required the Secretary of Education to develop a recommended Keystone Exam Composite Score subject to approval by the State Board of Education. Mr. Stem noted that, in May, the Department of Education presented a recommended composite score of 4452 and, as part of that presentation, explained how that recommendation was derived to take into consideration two standard errors. He said the composite score will allow for a student that may be stronger in one or more areas and weaker in others to have a pathway to graduate based on performance on the Keystone Exams.

Dr. Barker asked for clarification between standard deviation and standard error. Dr. Richard Maraschiello, Consultant to the Department, provided a technical explanation of the differences.

Sandra Dungee Glenn asked what year pathways including the Keystone Exam Composite Score take effect as graduation requirements. Deputy Secretary Stem shared that new graduation requirement take effect with the class of 2022.

# RECOMMENDED PERFORMANCE LEVEL DESCRIPTORS AND CUT SCORES FOR THE PENNSYLVANIA ALTERNATE SYSTEM OF ASSESSMENT IN ENGLISH LANGUAGE ARTS AND MATHEMATICS

Lynda Lupp, Statewide Special Education Assessment Coordinator with PaTTAN, and Lisa Hampe, Special Education Adviser with the Department of Education, reviewed the standards setting process that was used to develop recommended cut scores and revised performance level descriptors for the Pennsylvania Alternate System of Assessments (PASA) exams administered in English Language Arts and Mathematics. Ms. Lupp and Ms. Hampe discussed the population of students that take the PASA, and noted that the standards setting was necessary due to changes in the design of the PASA to move from three levels of complexity to two levels of complexity. They reviewed results of the standard setting process and presented the Secretary of Education's recommendation to the Board on the PASA cut scores.
